- 1. Any and all documents and communications concerning Grant Number R18 HS017045, given to Principal Investigator Ross Lazarus from Harvard Pilgrim Health Care, Inc., by the AHRQ (the "Grant"). This should include, but is not limited to, any and all documents and communications concerning proposals for the Grant, awarding of the Grant, and evaluation of the Grant.
- 2. Any and all documents and communications with Ross Lazarus, Michael Klompas, or Steve Bernstein, (the "Grant Personnel") concerning the Vaccine Adverse Event Reporting System ("VAERS"). This request should include, but is not limited to, any documents or communications concerning giving the Grant Personnel access to, permission to use, permission to interact with, or permission to submit data to VAERS.
- 3. Any and all documents and communications concerning both (a) the Grant or the Grant Personnel, and (b) the VAERS. This

request should include, but is not limited to, any internal documents or communications concerning giving the Grant Personnel access to, permission to use, permission to interact with, or permission to submit data to VAERS.

4. Any and all documents and communications concerning the report entitled "ELECTRONIC SUPPORT FOR PUBLIC HEALTH: VALIDATED CASE FINDING AND REPORTING FOR NOTIFIABLE DISEASES USING ELECTRONIC MEDICAL DATA," by Lazarus R., Klompas M., Campion FX, et al. published in the Journal of the American Medical Informatics Association's Jan-Feb 2009 edition; 16(1):18-24, available at https://healthit.ahrq.gov/sites/default/files/docs/publication/r18hs017045-lazarus-final-report-2011.pdf (the "Report").

Fees and charges for this search are to be waived pursuant to 5 U.S.C. § 552 (a)(4)(A)(iii) since ICAN is a not-for-profit 501(c)(3) organization and its mission is to raise public awareness about vaccine safety and provide the public with information to give informed consent. We further request that you describe any deleted or withheld material in detail and specify the statutory basis for the denial as well as your reasons for believing that the alleged statutory justification applies. Please also separately state your reasons for not invoking your discretionary powers to release the requested documents in the public interest. Such statements may help to avoid unnecessary appeal and litigation. ICAN of course reserves all rights to appeal the withholding or deletion of any information.

Access to the requested records should be granted within twenty (20) business days from the date of your receipt of this letter. Failure to respond in a timely manner shall be viewed as a denial of this request and ICAN may immediately file an administrative appeal.
