This matter pertains to procurement, supply and distribution of diphtheria, tetanus, pertussis biologic (DTP) by the United Nations International Children's Emergency Fund (UNICEF). DTP has shown to have negative health effects on children, which is why, between 1981 and 2008, developed countries of the world ceased its use for immunization programs in their younger populations. In the seminal study regarding DTP and mortality, world-renowned scientists found that children receiving this product during the first six months of life died at 10 times the rate when compared to children that did not receive this product. Despite this, and many similar studies, UNICEF continues to purchase, promote, and distribute DTP to developing and under-developed countries, and pushes its use on every newborn child long after knowing that the clear dangers it poses caused developed nations to stop using DTP decades ago. UNICEF has been aware of the risks associated with DTP and has been requested, multiple times, to stop promoting this product, or at least,

make sure that parents whose children are receiving this product are duly apprised of the risks associated with it pursuant to ethical codes. UNICEF has not responded to any of the communications; nor has it taken any action in this regard. The core human rights instruments such as the ICCPR and the ICESCR reaffirm the basic right to life, right to health and right to informed consent prior to medical interventions. UNICEF's conduct, through the DTP program, offends these fundamental rights.
