Re: Death of Infants in Certain Developing Countries by Systematic Use of a Biologic

Dear Ms. Bensouda:

On July 29, 2020, we submitted a referral requesting that your office investigate the continuous and systematic killing of innocent infants through the use of DTP in some of the most underprivileged countries of the world at the hands of the United Nations Children's Fund ("UNICEF"), the very organization charged with protecting the children of the world.

We write to supplement that request. Please find enclosed the video testimony of Mr. Kennedy Lumula and his wife, Ms. Felisias Nyambura, attesting to the loss of their two-month old daughter, Latifa Muthoni, within hours of being injected with DTP.

Mr. Lumula and his family reside in Nairobi, Kenya. On June 18, 2020, around 10 a.m., Mr. Lumula and Ms. Nyambura took their two-month old baby Latifa to receive her first round of newborn vaccines during which she was injected with DTP. As explained by her parents in the enclosed video testimony, Latifa was a healthy and happy baby but immediately after receiving DTP began to cry incessantly which hours later led to a change in her breathing pattern and death.

We can attest that the enclosed is the complete unedited testimony of Mr. Lumula and Ms. Nyambura. Their statement is solely theirs and they were not provided with any guidance or direction to recount their story other than being advised not to speculate and to tell the truth. Please note that while providing their testimony over a video conference there were connectivity issues on three occasions resulting in the video being recorded in four segments. These four segments were combined into a single video with an introductory screen stating "The oral testimony of

Kennedy Lumula & Felisias Nyambura Recorded on September 4, 2020" and a photograph of the deceased baby Latifa has been added at the end of the video.

This story is just one example of the pain and suffering experienced by parents around the world after the loss of an infant following injection of DTP. We again urge the Prosecutor to launch an investigation into the crimes against humanity alleged in our correspondence dated July 29, 2020. It is our sincere hope that the mere existence of an investigation will suffice to move the individuals responsible for distributing DTP to take action to end these senseless deaths.

We pray for a favorable response from the Prosecutor and thank you for reviewing our submissions.
