Dear Mr. Siri:

This letter is regarding to your Centers for Disease Control and Prevention and Agency for Toxic Substances and Disease Registry (CDC/ATSDR) Freedom of Information Act (FOIA) request of October 24, 2018, assigned #19-00086-FOIA, for

“Please provide each and every email communication between January 1, 2017 and October 24, 2018 which includes William Thompson on the “To”, “From”, “Cc” or “Bcc” line and also includes one or more of the following individuals on the “To”, “From”, “Cc” or “Bcc” line: Frank DeStefano, Coleen A. Boyle, Marshalyn Yeargin-Allsopp, Anne Schuchat. (For example, an email from William Thompson to Anne Schuchat and John Doe dated January 8, 2017 would be responsive to this request.)”

We located 108 pages of responsive records. After a careful review of these pages, some information was withheld from release pursuant to 5 U.S.C. §552 Exemptions 5 and 6. 11 pages were withheld in full.

Exemption 5 protects inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency. Exemption 5 therefore incorporates the privileges that protect materials from discovery in litigation, including the deliberative process, attorney work-product, and attorney-client privileges. Information withheld under this exemption was protected under the deliberative process privilege. The deliberative process privilege protects the decision-making process of government agencies. The deliberative process privilege protects materials that are both predecisional and deliberative. The materials that have been withheld under the deliberative process privilege of Exemption 5 are both predecisional and deliberative, and do not contain or represent formal or informal agency policies or decisions. Examples of information withheld include deliberative discussions among employees.

Exemption 6 protects information in personnel and medical files and similar files when disclosure would constitute a clearly unwarranted invasion of personal privacy. The information that has been withheld under Exemption 6 consists of personal information, such as personal email addresses and other private information within emails, and we have determined that the individual to whom this information pertains have a substantial privacy interest in withholding it.



I am still struggling with this mood and so will humor it by writing you a letter instead of working. I have been thinking of how little I have been writing – for such a long time now, it seems. Why am I always running now, and filling my days with what – I can't remember – but it must be important for me to work so hard at it. At the moment the thought of digging into the pile of paper work waiting for me makes me feel sick to my stomach. But, then I start in and after awhile the bad feeling goes away and I am OK. In the end I'll get it all done, and more.

Lovely sunrise this morning. That's my only complaint about the apartment – there is no comfortable spot for me to sit and watch the day wake up. The kitchen is cozy and a nice window, but no comfortable chair. The family room has the comfortable chair, but faces west. The living room faces east but not a very good view - maybe I need to rearrange the living room. Or maybe, rearrange my bedroom – it has the best window and faces east. Ian's room also has a great window, but faces west and gets the best sunsets – a benefit that he has commented on with great satisfaction. Now that the leaves have dropped from the trees, we get a wider and more dramatic view out of our windows. And the winter skies at dusk go all soft and purple. I am filled with great satisfaction on the evenings when we are home together at dusk, and its warm inside, and I light candles and watch the rich colors fade through the frosty windowpanes. We have started to have a family movie time on Friday nights and we all gather in Ian's room to watch it – with the sky as our backdrop. Even if the skies are grey and burdened with clouds, the bare tree branches define the skyline with drama and provide a satisfying contrast to the interior glow. It's a good thing and makes me feel better to think about it.

I have been thinking a lot about our last few weeks and our times together. I am filled with a secret joy at the richness and depth of our relationship. It seems to be reaching into higher levels and plunging into greater depths since I arrived in Aarhus.... Just when I think we have reached a perfect harmony, it surprises me and gets even better. Have you felt that too? There are some moments, when my heart is near bursting and I am afraid to speak for breaking the spell. Often, the moment is so brief that it passes and takes my breath away with it. I often wonder if you felt the same, but am afraid for asking in case you didn't – that would be terrible! Then again, I sense other moments when I feel you are carried away also

My dear Poul,

At last I have some free time to write you the chatty letter I have wanted to write for a week now. Since I left you and Denmark (you know, I am really becoming very attached to your country as I learn, and observe, and discover more and more on my own - for its own sake, and not just because you are there....oh, and guess what! The viking ship sculpture is back in the hillside en route to Bent's house - poised for tragedy, mystery, and ghostly shadows. I don't know when the best time to see it would be, wrapped in fog at winter day break, or in the bright sun and waving green grass of spring. Try both times and tell me what you thinkbut, these are other topics of discussion and I need to get back to the beginning of this sentence)..... I have had countless conversations with you in my mind, and mentally composed many paragraphs of many letters. Few hours go by that you don't come into my thoughts, and I wish that I could dash off the lines right at that instant so you would know that I am thinking of you. Although you are less inclined to write, I know you are thinking of me too, and often - imagine all of that psychic energy flying across the Atlantic! But, please remember this about me - that you are ever, always, my companion in thought and inner feeling, even during long weeks of separation and unfortunate days of silence.

But, the main idea I have wanted to share with you recently is something I read in one of my current books (I usually have at least 2 books that I am reading at any one time - and I switch back and forth depending on my mood and degree of tiredness). I think you saw it at the summer house, "Galileo's Daughter". As you know his astronomical observations challenged the strict interpretation of biblical accounts of creation and upset all kinds of insecure religious leaders. Ironically, he was a devote Catholic and did not see any conflict in what he observed as a learned professional and what he believed as a Catholic. And he had his supporters all through out Europe, even some Danish astronomers whose writings he consulted! (aren't all these connections wonderful), and many of them wrote opinions and texts that are astonishingly fresh and clear thinking. I say, "astonishing" only because I am inclined to imagine that 500 years ago the level of ignorance was so great as to make it pointless to read it. But, I have been humbled - again. On the plane ride home from Denmark, I read a few passages that electrified me - mainly because they were beautifully written, and revealed a beautiful mind - and I instantly wanted to share them with you. If you had been sitting next to me, I would have grabbed your arm in excitement and undoubtedly spilled your drink or upset your fork poised in mid-air. So, here they are.

The first is taken from a letter that Galileo wrote to a colleague, and he makes an analogy (in music) about the difficulties in logic and observation that the church puts itself in to try and maintain that the earth is the center of the universe and does not move. And since he is also trying to figure out the correct logic, mostly by just observing and reasoning, he is cautious himself. So he says:

"Nevertheless, I shall not abandon the task in despair. Indeed, I hope that this new thing will turn out to be of admirable service in tuning for me some reed in this great discordant organ of our philosophy - an instrument on which I think I see many organists wearing themselves out trying vainly to get the whole thing into perfect harmony. Vainly, because they leave (or rather preserve) three or four of the principal reeds in discord, making it quite impossible for the others to respond in perfect tune."

Do you see what he is saying, that by failing, or unwilling, to replace the parts that don't work, the whole system fails. Simple idea, but beautifully expressed, I think. Is this not the struggle we face every day, when we face our scientific problems? (well, maybe even facing our problems of life, also!)

And, in this next passage he separates religion and science in clear and eloquent argument, that I wish everyone who has ever debated the roles of these two institutions should read!

"I believe that the intention of Holy Writ was to persuade men of the truths necessary for salvation such as neither science nor any other means could render credible, but only the voice of the Holy Spirit. But I do not think it necessary to believe that the same God who gave us our senses, our speech, our intellect, would have put aside the use of these, to teach us instead such things as with their help we could find out for ourselves, particularly in the case of these sciences of which there is not the smallest mention in the scriptures;"

Do you feel the same humility as I did, when I first read these lines? Imagine, looking into the depths of the universe with a piece of polished glass and, with only that, reasoning out some of its most fundamental truths. And then expressing the thoughts and arguments so eloquently and clearly.

The rest of the book has many such lines, and many others that are much less inspiring. A good read altogether.

The other book I am reading is soft and soothing, for when I am tired and don't want a challenge, or another second of stimulation. I am tired now.

I miss being with you, Poul, very much. I like what I am with you.

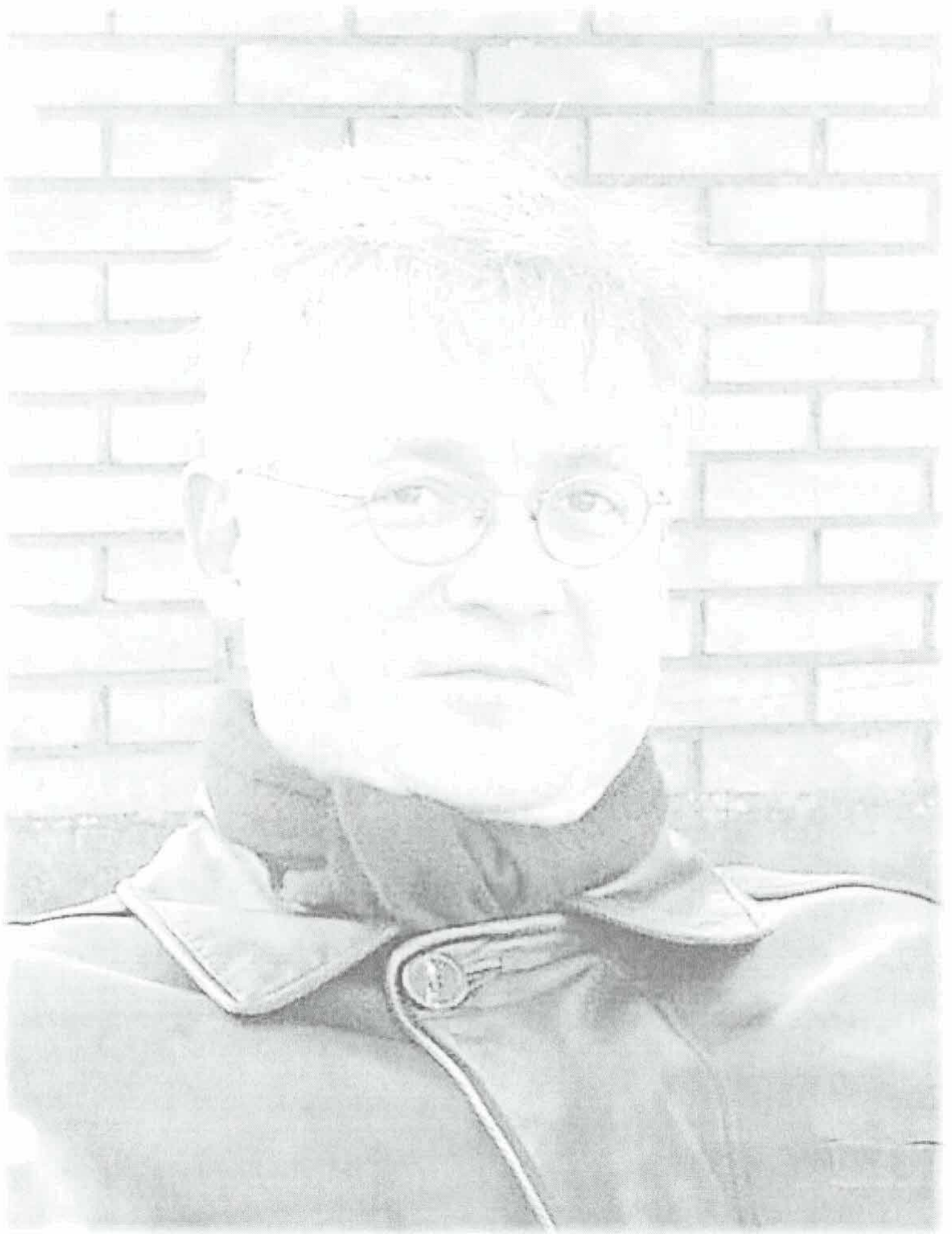

Thank you for your July 7, 2011 response to my Sept. 15, 2010 email and Nov. 24, 2010 email regarding the scientific misconduct of Dr. Poul Thorsen.

Dr. Thorsen was a “scientist in residence” at the United States Centers for Disease Control (CDC) between 2000 and 2002. At this time, the CDC was very concerned regarding the putative causal relationship between infant vaccinations and autism. In fact, the CDC commissioned the Institute of Medicine (a body independent of the U.S. Government and commercial interests) of the U.S. National Academy of Sciences to specifically investigate this issue.

In the summer of 2001, the Institute of Medicine (IOM) was about to issue a report stating that it had found the relationship between mercury exposure via Thimerosal-preserved vaccines and autism incidence to be biologically plausible, based on a comprehensive review of the most current scientific literature.

This decision was very unpopular within the CDC and chief scientists within the National Immunization Program (of the CDC) set out to find autism incidence and vaccine uptake data in other countries that might be able to be used to disprove such a causal relationship. As such, Dr. Thorsen was approached to serve as a liaison between the CDC and Denmark scientists to facilitate an investigation into the incidence of autism in Denmark after the phase out of Thimerosal-preserved vaccines in 1992.

After the relationship had been established with Dr. Thorsen in 2000, Dr. Diane Simpson, Acting Deputy Director of the National Immunization Program (NIP), contacted one of Thorsen’s colleagues in Denmark, Dr. Kreesten Madsen to access autism incidence data, in hopes that the causal relationship between thimerosal containing vaccines and autism could be disproven [see **Exhibits 1 and 2**]. Dr. Simpson specifically asked whether autism incidence rates went up in the 1990’s and Dr. Madsen replied that they had gone up only slightly and that this could be explained by varying diagnostic criteria used to account for autism cases and by the inclusion of outpatient clinics in counting these cases starting in 1995 [see **Exhibit 1**]. Denmark had phased out Thimerosal-preserved vaccines in 1992 and the CDC was looking for data that showed a significant increase in autism rates after this date [see **Exhibit 1**], which could be used to disprove the “autism-thimerosal” theory, and the Danish researchers involved obviously tried their best to generate a paper that provided what the CDC wanted.

Despite the fact that autism rates did not increase dramatically after 1992, Dr. Simpson visited Denmark in August, 2001, and entered into a collaboration with scientists at Aarhus University (including Dr. Thorsen). This led to the publication of the paper, “Thimerosal and

the occurrence of autism: negative ecological evidence from Danish population-based data” that appeared in the journal *Pediatrics* in 2003 [Madsen KM, Lauritsen MB, Pedersen CB, Thorsen P, Plesner A-M, Andersen PH, Mortensen PB. Thimerosal and the Occurrence of Autism: Negative Ecological Evidence From Danish Population-Based Data. *Pediatrics* 2003 Sep; 112(3): 604 -606].

Based on redacted copies of pertinent e-mails obtained from the CDC under the US Freedom of Information Act (FOIA), it was clear that Dr. Poul Thorsen:

- Knew, *contrary to the paper's assertions*, that the “incidence and prevalence” rates for autism had dropped after the removal of the Thimerosal-preserved (“Thimerosal-containing”) vaccines from the Danish vaccination program in 1992 (see Exhibit 3), and
- Acted to facilitate the publication of a knowingly misleading article (see Exhibit 4).

From the context of the **Exhibit 3**'s e-mail, it is clear that, at a minimum, Kreestenn Meldgaard Madsen, Marlene Briecciet Lauritsen, and Poul Thorsen knew that the autism rates declined after the Thimerosal-containing vaccines were withdrawn from the Danish vaccination program as did the CDC (Diana M. Schendel).

The Madsen et al. (2003) paper was riddled with severe methodological flaws and the purported increases in autism rates in Denmark may be explained by three phenomena that occurred after 1992, when Thimerosal-containing vaccines were phased out of the Danish vaccination program.

1. First, the National Center for Registry Based Research (NCRB), which stewarded the autism incidence data, changed accounting methods and started counting autism cases based on outpatient visits in 1995 [see Exhibit 1], whereas, before this date, only inpatient (hospital) visits were recorded. This alone led to an estimated 13.5-fold increase in autism cases as reported in Madsen et al. (2002) [*NEJM* 2002; **347**: 1477].
2. Second, in 1994, the NCRB changed diagnostic criteria for autism from ICD8 (psychosis infantilis posterior) to ICD10 (infantile autism) [see Exhibit 1]. This alone would lead to an approximate 5-fold increase in autism cases based on the estimation presented in Trelka and Hooker (2004) [Trelka JA, Hooker BS. Correspondence: More on Madsen's Analysis. *J Am Physicians Surgeons* 2004 Winter; **9**(4): 101].
3. Finally, the authors of the Madsen et al. (2003) publication neglected to account for the inclusion of a large outpatient clinic in Copenhagen in 1992, which accounted for 20% of the autism cases nationwide [Trelka and Hooker (2004)].

Taken together, these three confounding factors account for the entire increase in autism diagnoses after 1992. In fact, one comprehensive review of the data as published showed that autism rates could have *decreased* after 1992 by as much as 75% [Trelka and Hooker (2004)]. The authors (including Thorsen) appear to have obfuscated the underlying trends in the data by neglecting these three factors in their analysis. This led to one journal's outright rejecting the manuscript for publication.

After this, Dr. Thorsen contacted CDC researcher Dr. Diana Schendel to recruit Dr. Jose Cordero, the then Director of the National Center for Birth Defects and Developmental

Disabilities of the CDC, to write a recommendation letter for expedited publication of the paper in the journal *Pediatrics*.

The most egregious example of misconduct was carried out in the data analysis leading to the Madsen et al. (2003) publication. In a Nov. 13, 2002 email correspondence obtained from the CDC via the Freedom of Information Act, Dr. Marlene Lauritsen, co-author of the publication, stated that the autism rates between 1999 and 2001 were actually decreasing.

Regarding the autism rates, Dr. Lauritsen stated, "But the incidence and prevalence rates are still decreasing in 2001" [see **Exhibit 3**]. These data did not support the assertion of the paper that thimerosal exposure was not causally related to autism. However, the final version of the published article did not include any of the 2001 data. The inclusion of this data would have, *at a minimum*, nullified the conclusions of the paper and could have indeed reversed them, showing a causal relationship between Thimerosal exposure and autism incidence in Denmark.

There have been several requests for the original data in order to repeat this study. However, the data have never been released to the public. Most notably, researchers Dr. Brian Hooker and Mr. Jeffrey Trelka (Autism Healing Network) submitted a letter to the editor of the journal *Pediatrics*, rebutting the Madsen et al. (2003) publication. Upon receipt, the editor of the journal forwarded the letter to the co-authors, who chose not to respond. This lack of transparency on the part of the Madsen et al. (2003) publication authors is, *at a minimum*, curious, especially considering the severe methodological flaws in the published paper.

To summarize, in the Madsen et al. (2003) paper, Dr. Poul Thorsen apparently colluded with several of his co-authors to withhold data that does not support the published paper's conclusions, apparently conspired to misrepresent the reported data to lead readers to believe that the autism rates in Denmark increased dramatically after 1992 when they actually decreased, and apparently conspired to conceal the role of the CDC in producing this publication as shown by the e-mails in **Exhibits 1-5**.

I am writing in support of an expedited review and consideration of the enclosed manuscript that examines the association between thimerosal, an ethyl mercury containing preservative, and autism. As you may know, there has been considerable interest by parents, clinicians, educators, and policy makers for an explanation of the marked increase in the rate of autism in recent years. A University of Davis study released in October of children identified through the California developmental disabilities service system, reemphasized the upward trend in autism and the lack of understanding as to the cause.

One factor hypothesized to have a causal role is childhood vaccinations. Specific aspects of vaccinations that have been subject to inquiry include the MMR vaccine and thimerosal. There are now numerous epidemiologic studies to suggest that the MMR vaccine is not associated with the risk of autism; an Institute of Medicine review that was published in 2000 concluded that the weight of the scientific evidence did not support a link between MMR vaccine and autism.

For thimerosal, however, there are limited data to evaluate this factor. Because mercury in its inorganic form is known to have serious neurologic effects, many parents have speculated that the increased number of vaccines (many of which contained thimerosal) may have been a significant factor in the recent rise in autism. The Danish study is a powerful epidemiologic study of this issue and capitalizes on the Danish health registry system that incorporates all health encounters into disease and exposure specific registries. In addition, a key strength of the study is the ability to examine rates of autism prior to and after the *discontinuation* of vaccines containing thimerosal in Denmark in 1992. Contrary to what would be expected if thimerosal was linked to autism, the authors did not observe a decline in the rate of autism with the removal of thimerosal containing vaccines.

I am filled with great satisfaction on the evenings when we are home together at dusk, and its warm inside, and I light candles and watch the rich colors fade through the frosty windowpanes. We have started to have a family movie time on Friday nights and we all gather in Ian's room to watch it – with the sky as our backdrop. Even if the skies are grey and burdened with clouds, the bare tree branches define the skyline with drama and provide a satisfying contrast to the interior glow. It's a good thing and makes me feel better to think about it.

I have been thinking a lot about our last few weeks and our times together. I am filled with a secret joy at the richness and depth of our relationship. It seems to be reaching into higher levels and plunging into greater depths since I arrived in Aarhus.... Just when I think we have reached a perfect harmony, it surprises me and gets even better. Have you felt that too? There are some moments, when my heart is near bursting and I am afraid to speak for breaking the spell. Often, the moment is so brief that it passes and takes my breath away with it. I often wonder if you felt the same, but am afraid for asking in case you didn't – that would be terrible! Then again, I sense other moments when I feel you are carried away also

My dear Poul,

At last I have some free time to write you the chatty letter I have wanted to write for a week now. Since I left you and Denmark (you know, I am really becoming very attached to your country as I learn, and observe, and discover more and more on my own - for its own sake, and not just because you are there....oh, and guess what! The viking ship sculpture is back in the hillside en route to Bent's house - poised for tragedy, mystery, and ghostly shadows. I don't know when the best time to see it would be, wrapped in fog at winter day break, or in the bright sun and waving green grass of spring. Try both times and tell me what you thinkbut, these are other topics of discussion and I need to get back to the beginning of this sentence)..... I have had countless conversations with you in my mind, and mentally composed many paragraphs of many letters. Few hours go by that you don't come into my thoughts, and I wish that I could dash off the lines right at that instant so you would know that I am thinking of you. Although you are less inclined to write, I know you are thinking of me too, and often - imagine all of that psychic energy flying across the Atlantic! But, please remember this about me - that you are ever, always, my companion in thought and inner feeling, even during long weeks of separation and unfortunate days of silence.

But, the main idea I have wanted to share with you recently is something I read in one of my current books (I usually have at least 2 books that I am reading at any one time - and I switch back and forth depending on my mood and degree of tiredness). I think you saw it at the summer house, "Galileo's Daughter". As you know his astronomical observations challenged the strict interpretation of biblical accounts of creation and upset all kinds of insecure religious leaders. Ironically, he was a devote Catholic and did not see any conflict in what he observed as a learned professional and what he believed as a Catholic. And he had his supporters all through out Europe, even some Danish astronomers whose writings he consulted! (aren't all these connections wonderful), and many of them wrote opinions and texts that are astonishingly fresh and clear thinking. I say, "astonishing" only because I am inclined to imagine that 500 years ago the level of ignorance was so great as to make it pointless to read it. But, I have been humbled - again. On the plane ride home from Denmark, I read a few passages that electrified me - mainly because they were beautifully written, and revealed a beautiful mind - and I instantly wanted to share them with you. If you had been sitting next to me, I would have grabbed your arm in excitement and undoubtedly spilled your drink or upset your fork poised in mid-air. So, here they are.

The first is taken from a letter that Galileo wrote to a colleague, and he makes an analogy (in music) about the difficulties in logic and observation that the church puts itself in to try and maintain that the earth is the center of the universe and does not move. And since he is also trying to figure out the correct logic, mostly by just observing and reasoning, he is cautious himself. So he says:

"Nevertheless, I shall not abandon the task in despair. Indeed, I hope that this new thing will turn out to be of admirable service in tuning for me some reed in this great discordant organ of our philosophy - an instrument on which I think I see many organists wearing themselves out trying vainly to get the whole thing into perfect harmony. Vainly, because they leave (or rather preserve) three or four of the principal reeds in discord, making it quite impossible for the others to respond in perfect tune."

Do you see what he is saying, that by failing, or unwilling, to replace the parts that don't work, the whole system fails. Simple idea, but beautifully expressed, I think. Is this not the struggle we face every day, when we face our scientific problems? (well, maybe even facing our problems of life, also!)

And, in this next passage he separates religion and science in clear and eloquent argument, that I wish everyone who has ever debated the roles of these two institutions should read!

"I believe that the intention of Holy Writ was to persuade men of the truths necessary for salvation such as neither science nor any other means could render credible, but only the voice of the Holy Spirit. But I do not think it necessary to believe that the same God who gave us our senses, our speech, our intellect, would have put aside the use of these, to teach us instead such things as with their help we could find out for ourselves, particularly in the case of these sciences of which there is not the smallest mention in the scriptures;"

Do you feel the same humility as I did, when I first read these lines? Imagine, looking into the depths of the universe with a piece of polished glass and, with only that, reasoning out some of its most fundamental truths. And then expressing the thoughts and arguments so eloquently and clearly.

The rest of the book has many such lines, and many others that are much less inspiring. A good read altogether.

The other book I am reading is soft and soothing, for when I am tired and don't want a challenge, or another second of stimulation. I am tired now.

I miss being with you, Poul, very much. I like what I am with you.

Just for historical purposes, I think everyone should know how I have been involved in the Thimerosal and MMR autism studies over the last 13 years.

1. I was the project officer on the 2 most expensive thimerosal studies the CDC carried out. Over \$10 million dollars was spent carrying these 2 studies out. The 2 studies took 10 years to complete. I also finished and published a reanalysis of these 2 studies in 2012. As I have told Marshalyn, I plan on doing no vaccine safety studies in the future.
2. Sal told me by e-mail that I need to share my study notes associated with all of these studies. I have not done that previously and I am not sure that anyone else has. If they have, no one has told me that they have actually done that.
3. Therefore, I have a whole lot of study notes to review that are interspersed with a whole lot of other information in them. They cannot not be easily searched for either the Congressional request or the FOIAs.
4. Interspersed throughout these notes is a lot of personal private information including information (b)(6) February 2004.
5. I have had to consult with a lawyer previously when there were questions about what needed to be shared (b)(6) In November 2003 I shared everything I had including analyses and results from several of these studies and I am assuming they were screened out of what was shared with the DOJ and Congress but I have never been told that was actually the case since no one communicates what's been shared.
6. In the last Congressional request this last spring, I shared everything again, and this time many of the e-mails were leaked to individuals outside congress which included e-mails I had written (b)(6) So clearly a whole new set of rules is being used for what is shared and what isn't shared and no information is being shared with those of us that it actually impacts. My assumption is that HIPAA rules were violated because I don't think anyone actually knew what they were sharing. There was also a note added to the document that was shared that I would like to know who added it.
7. Last but not least, I presented a whole lot of Dianna Schendel's study results with Dr. Thorsen to a whole lot of people inside the CDC. If what I am hearing outside our center

is true, then it seems like there are conflicts of interest that have not been shared with people in the scientific community. I am tired of this shit.

The Office of General Counsel at CDC is a branch of HHS/OGC so there is no real distinction between the two entities. Any program person can reach out to our OGC attorney-advisors on any issue. Sudevi Ghosh serves in this capacity for our Center. While there is no requirement to do so, many of the program requests to OGC are routed through this office for a response. In the case of FOIA, all requests should be routed through Kim Smith and this office for response.

Finally, as you probably know Executive Branch staff are generally not permitted to engage Congress directly. These interactions are generally managed by CDC/OD staff offices (CDC/W, FMO/L) or HHS (ASL). Any interactions we have on this or any other issue would be managed by one of these administrative offices. Further, in the event a Congressional staffer reaches out to you directly in any manner (phone, email, cell phone, correspondence), that staffer or the correspondence should be referred to my office (me or Kinzie Lee) immediately for a coordinated response through proper channels.

 - c. *In addition I would suggest running the analyses with and without the priors to see how the results change (using the more traditional Bonferroni adjustment)*
