





Of note, there is an interagency working group that has just developed recommendations as well. I think it important hat any document that comes out is harmonized with that effort. Below is a draft of a somewhat different initial paragraph to give you an idea of where I think this needs to go:

At present in the US there are no licensed, approved drugs specifically for the treatment of patients with COVID-19. As of March 19, 2020, clinical management includes infection prevention and control support measures and supportive care including supplementary oxygen and mechanical ventilatory support when indicated. An array of drugs licensed for other indications as well as several investigational drugs are being studied in several hundred clinical trials that are underway across the globe. While a variety of reports have appeared in the medical literature and the lay press claiming successful treatment with some of these agents it is important to stress that at this time there is no drug that has been shown to be safe and effective for the treatment of COVID-19. The purpose of this document is to provide information on three of the licensed drugs (chloroquine, hydroxychloroquine and kaletra) and one of the investigational agents (remdesivir) currently in use in the US.



Attached is the memo that we discussed. Genentech has had very productive on-going conversations with both FDA and BARDA regarding possible usage of Actemra to treat a sub-set of very ill COVID-19 patients.

 Genentech/Roche's priority is to conduct a randomized, controlled clinical trial to test the safety and efficacy of Actemra (tocilizumab) for the treatment of severely ill COVID-19 patients

- Toward this end, we are committed to working with the FDA, in collaboration with BARDA, to develop, enroll, and complete this clinical study as our first priority
- Separately, we seek to enter into an agreement with BARDA under our existing Other Transactions Authority (OTA) agreement that would allow for a donation of an initial 4000 vials of Actemra to the U.S. government reserved for patient treatment outside of the clinical trial, only in the event of an escalating emergency, should physicians decide to prescribe this product off label.
- Under this agreement, Genentech would seek assistance from BARDA (and appropriate federal agencies) to develop and disseminate guidelines for appropriate clinical use and to coordinate with Genentech's distribution capabilities.

President Trump's Science Advisor and the National Academies of Sciences, Engineering, and Medicine Commit to Collaborative Effort on the Coronavirus White House OSTP and NASEM to Gather Subject Matter Experts on Origination of 2019nCov

Yesterday, Dr. Kelvin Droegemeier, Director of The White House Office of Science and Technology Policy (OSTP) sent a letter to Dr. Marcia McNutt, President of the National Academy of Sciences, calling for the National Academies of Sciences, Engineering, and Medicine (NASEM) to rapidly examine information and identify data requirements that would help determine the origins of 2019-nCoV.

"Although a widely-disputed paper, 'Uncanny similarity of unique inserts in the 2019-nCoV spike protein to HIV-1 gp120 and Hag,' posted on the pre-print server bioRxiv last week has been withdrawn, the response to that manuscript highlights the need to determine information and data requirements as quickly as possible to better perform and validate such analyses of origin. These questions are important not only for this current situation, but to inform future outbreak preparation and better understand animal/human and environmental transmission aspects of coronaviruses. As part of a broader deliberative process, this review will aid preparedness for future events by establishing a process that quickly assembles subject matter experts for evaluating other potentially threatening organisms.

OSTP requests NASEM convene a meeting of experts, particularly world class geneticists, coronavirus experts, and evolutionary biologists, to assess what data, information, and samples are needed to address the unknowns, in order to understand the evolutionary origins of 2019-nCo V and more effectively respond to both the outbreak and any resulting misinformation. I request a letter statement from the National Academies be prepared and provided in response to this solicitation. A more in-depth examination of the issues will be established as a follow up as needed," **Dr. Kelvin Droegemeier wrote in the letter.**

Subsequently, the National Academies of Sciences, Engineering, and Medicine responded in a joint letter from Dr. Marcia McNutt, President of the National Academy of Sciences; Dr.

John L. Anderson, President of the National Academy of Engineering; and Dr. Victor J. Dzau, President of the National Academy of Medicine.

"In response to your request, we consulted leading experts in the fields of virology, infectious disease genomics, genome sciences, epidemiology, microbiology, immunobiology, coronaviruses, emerging infections, biosecurity, and global health. We wanted their views about the data needs that could help elucidate the origin and evolution of 2019-nCoV.

"The National Academies stand ready to assemble a committee of experts to examine these issues in more detail and provide evidence-based advice to you in an expedited manner if requested. We appreciate your trust in the National Academies and our efforts to advise the nation and inform public policy decisions," the three presidents wrote in the letter.

Study claiming new coronavirus can be transmitted by people without symptoms was flawed

A <u>paper published on 30 January</u> in *The New England Journal of Medicine (NEJM)* about the first four people in Germany infected with a novel coronavirus made many headlines because it seemed to confirm what public health experts feared: that someone who has no symptoms from infection with the virus, named 2019-nCoV, can still transmit it to others. That might make controlling the virus much harder.

Chinese researchers had previously suggested asymptomatic people might transmit the virus but had not presented clear-cut evidence. "There's no doubt after reading [the *NEJM*] paper that asymptomatic transmission is occurring," Anthony Fauci, director of the U.S. National Institute of Allergy and Infectious Diseases, told journalists. "This study lays the question to rest."

But now, it turns out that information was wrong. The Robert Koch Institute (RKI), the German government's public health agency, has written a letter to *NEJM* to set the record straight, even though it was not involved in the paper.

The letter in *NEJM* described a cluster of infections that began after a businesswoman from Shanghai visited a company near Munich on 20 and 21 January, where she had a meeting with the first of four people who later fell ill. Crucially, she wasn't sick at the

time: "During her stay, she had been well with no sign or symptoms of infection but had become ill on her flight back to China," the authors wrote. "The fact that asymptomatic persons are potential sources of 2019-nCoV infection may warrant a reassessment of transmission dynamics of the current outbreak."

But the researchers didn't actually speak to the woman before they published the paper. The last author, Michael Hoelscher of the Ludwig Maximilian University of Munich Medical Center, says the paper relied on information from the four other patients: "They told us that the patient from China did not appear to have any symptoms." Afterward, however, RKI and the Health and Food Safety Authority of the state of Bavaria did talk to the Shanghai patient on the phone, and it turned out she did have symptoms while in Germany. According to people familiar with the call, she felt tired, suffered from muscle pain, and took paracetamol, a fever-lowering medication. (An RKI spokesperson would only confirm to *Science* that the woman had symptoms.)

Hoelscher was not on the call, he says. "I asked the Bavarian Health and Food Safety Authority whether the information from that phone conversation called for a correction and I was told that is not the case," he says. (The Bavarian ministry of health, of which the agency is part, has not responded to a request for information from *Science*Insider.) But RKI disagreed. The agency's spokesperson confirms that a letter about the error has been submitted to *NEJM*. RKI also informed the World Health Organization (WHO) and European partner agencies about the new information.

"I feel bad about how this went, but I don't think anybody is at fault here," says virologist Christian Drosten of the Charité University Hospital in Berlin, who did the lab work for the study and is one of its authors. "Apparently the woman could not be reached at first and people felt this had to be communicated quickly."

Marc Lipsitch, an epidemiologist at the Harvard T.H. Chan School of Public Health, says calling a case asymptomatic without talking to the person is problematic. "In retrospect, it sounds like this was a poor choice," he says. However, "In an emergency setting, it's often not possible to talk to all the people," he adds. "I'm assuming that this was an overstretched group trying to get out their best idea of what the truth was quickly rather than somebody trying to be careless."

The Public Health Agency of Sweden reacted less charitably. "The sources that claimed that the coronavirus would infect during the incubation period lack scientific support for this analysis in their articles," says a document with frequently asked questions **the agency posted on its website yesterday**. "This applies, among other things, to an article in [NEJM] that has subsequently proven to contain major flaws and errors." Even if the patient's symptoms were unspecific, it wasn't an asymptomatic infection, says Isaac Bogoch, an infectious disease specialist at the University of Toronto. "Asymptomatic means no symptoms, zero. It means you feel fine. We have to be careful with our words."

Hoelscher agrees that the paper should have been clearer about the origin of the information about the woman's health. "If I was writing this today, I would phrase that

differently," he says. The need to share information as fast as possible, along with *NEJM*'s push to publish early, created a lot of pressure, he says.

Given how fast data are coming out amid the growing global crisis, it's good to read even peer-reviewed papers with some extra caution at the moment, Lipsitch says: "I think peer review is lighter in the middle of an epidemic than it is at normal speed, and also the quality of the data going into the papers is necessarily more uncertain."

The fact that the paper got it wrong doesn't mean transmission from asymptomatic people doesn't occur. Fauci, for one, still believes it does. "This evening I telephoned one of my colleagues in China who is a highly respected infectious diseases scientist and health official," he says. "He said that he is convinced that there is asymptomatic infection and that some asymptomatic people are transmitting infection." But even if they do, asymptomatic transmission likely plays a minor role in the epidemic overall, WHO says. People who cough or sneeze are more likely to spread the virus, the agency wrote in a situation report on Saturday. "More data may come out soon. We will just have to wait," Lipsitch says.

The German cluster does reveal another interesting aspect about the new virus, Drosten says. So far most attention has gone to patients who get seriously ill, but all four cases in Germany had a very mild infection. That may be true for many more patients, Drosten says, which may help the virus spread. "There is increasingly the sense that patients may just experience mild cold symptoms, while already shedding the virus," he says. "Those are not symptoms that lead people to stay at home."







Secretary Azar Delivers Remarks on Declaration of Public Health Emergency for 2019 Novel Coronavirus

As Prepared for Delivery

Good afternoon, I am Alex Azar, Secretary of Health and Human Services, and Chairman of the President's task force on novel coronavirus.

I will start by turning it over to Dr. Robert Redfield, Director of the Centers for Disease Control and Prevention, to discuss the current situation on the novel coronavirus.

[Redfield briefs.]

I now invite Dr. Anthony Fauci, Director of the National Institute of Allergy and Infectious Diseases, to discuss the underlying rationale for today's actions.

[Fauci briefs.]

Today, President Trump took decisive action to minimize the risk of the spread of the coronavirus in the United States.

Since taking office, President Trump has been clear: His top priority is the safety of the American people.

In addition to the steps that the doctors have outlined, we continue to operationalize a multi-layered, cross-agency public health response.

Following the World Health Organization's decision to declare the 2019 novel coronavirus a Public Health Emergency of International Concern, I have declared today that the

coronavirus presents a Public Health Emergency in the United States.

The actions we have taken and continue to take complement the work of China and the WHO to contain the outbreak within China.

In accordance with the declaration, beginning 5 PM Eastern Standard Time, Sunday, February 2, the U.S. government will implement temporary measures to increase our abilities to detect and contain the coronavirus proactively and aggressively.

Any U.S. citizen returning to the U.S. who has been in Hubei Province in the previous 14 days will be subject to up to 14 days of mandatory quarantine, to ensure they're provided proper medical care and health screening. To be clear, this applies only to U.S. citizens who have been in Hubei Province in the past 14 days.

Any U.S. citizen returning to the U.S. who has been in the rest of mainland China within the previous 14 days will undergo proactive entry health screening at a select number of ports of entry and up to 14 days of monitored self-quarantine to ensure they have not contracted the virus and do not pose a public health risk.

Additionally, the President has signed a Presidential Proclamation, using his authority pursuant to Section 212(f) of the Immigration and National Act, temporarily suspending the entry into the United States of foreign nationals who pose a risk of transmitting the 2019 novel coronavirus.

As a result, foreign nationals, other than immediate family of U.S. citizens and permanent residents, who have traveled to China within the last 14 days will be denied entry into the U.S. for this time.

Once again, these actions will become effective at 5 PM EST, Sunday, February 2.

These prudent and targeted actions will decrease the pressure on public health officials screening incoming travelers, expedite the processing of U.S. citizens returning from China, and ensure resources are focused on the health and safety of the American people.

I want to stress: The risk of infection for Americans remains low, and with these and our previous actions, we are working to keep the risk low.

All agencies are working aggressively to monitor this continuously evolving situation and to keep the public informed.

The United States appreciates China's efforts and coordination with public health officials across the globe and continues to encourage the highest levels of transparency.

It is likely that we will continue to see more cases in the United States in the coming days and weeks, including some limited person-to-person transmission.

The American public can be assured: The full weight of the U.S. government is working to safeguard the health and safety of the American people.

I now invite Deputy Secretary of State Steve Biegun for an update.
