### Dear COM All,

Many of you have approached several members of our leadership team over the past several days wondering when you will be able to receive your first dose of the COVID-19 vaccine. If you have been following the recent local, state and national news, you know that expanding vaccine distribution is a current challenge in most locations, with some entities receiving an abundance of doses and others not. For a college like ours that covers a large geographic footprint and multiple clinical partners, we have to rely on the doses those partners can secure, in addition to the recent allotment received as a result of the college's application to the Texas Department of State Health Services (DSHS).

In some of our campus locations, our health care partners were allocated large shipments and had sufficient supply to generously share doses with some of our clinical personnel and students who reside on their campuses. Our clinical partners on other campuses received a more modest number of doses and have struggled to deliver vaccines to their own direct patient care teams. This has resulted in some groups of people on one campus getting a dose, while those in similar positions on other campuses have not.

This past week, our College of Medicine in Bryan-College Station received its first shipment of 100 doses of the Moderna vaccine, allowing us to hold our initial vaccine clinic over in Clinical Building 1. The majority of this small allotment was administered to our own College of Medicine employed frontline essential health care workers (HCW) in B-CS.

The Texas A&M Health Vaccination Task Force is a team effort across the Health Science Center colleges. Its charge is to provide the vaccine at the colleges for direct health care workers and other populations as vaccines are allotted by DSHS to Texas A&M Health. For example, the vaccines received by College of Pharmacy will go to College of Dentistry, College of Nursing and College of Medicine faculty and students involved in direct patient care. The vaccine received by College of Medicine are also going to College of Medicine, College of Nursing, and College of Pharmacy faculty and students. We, as a member of the Texas A&M Health Vaccination Task Force, are prioritizing directing the vaccine to the highest priority groups.

We are awaiting notification from the Texas DSHS regarding when our next shipment will be delivered and hope to receive additional information regarding our next allocation later this week. It is likely we will receive another limited allotment of doses in this round. Our College of Medicine vaccination team is working to accelerate distribution as we receive more doses. Currently, the focus remains on HCWs who are actively involved in patient care and a gradual transition to Phase 1B patients who are of an age or have health conditions that puts them at greater risk for complications from COVID-19. Going forward, the college is finalizing an online sign-up system that will allow us to maintain a waiting list to schedule your initial vaccine dose based on individual classification as 1A, 1B, or 2, as per the Texas DSHS and CDC guidelines.

Because distribution of doses is a global challenge, I want to encourage you to sign up on multiple lists and get a dose wherever first possible. Should an opportunity come up before we are able to call you in, I would encourage you to take it, but know that we are all working to get more doses in as soon as we can. All health care entities in the Brazos Valley are dealing with the same set of frustrations over vaccine supply and demand. Please be watching my weekly ACTS Friday emails for ongoing updates and notices. I will routinely give an update of College of Medicine vaccination numbers, as well as any new or additional information as we receive it. Even after vaccination, I encourage you to continue holding the very successful general recommendations based on social distancing, appropriate masking, frequent handwashing, reporting exposure/symptom/positive concerns, and staying home when ill. While we are all tiring of this new routine, it is critical for us to continue leading by example as we hold the Maroon Line. Thank you all for your ongoing patience and resilience as we navigate this as a COMmunity.







Colleagues

Your Texas A&M Health colleagues are doing some amazing work battling COVID across Texas.

Here in Bryan/College Station, the Brazos County Community COVID-19 Vaccination Hub alone just surpassed a milestone of vaccinating 65,000 people, including first and second doses. That accomplishment made possible by the collaboration of multiple organizations and support staff, including folks from Texas A&M Health and TAMU.

Of significance was the contributions made by our very own **Office of Information of Technology (OIT)** at Texas A&M Health in the <u>development of the very system that made scheduling all of those</u> <u>vaccinations possible</u>.

While it's not often that you hear about the behind the scenes work, our OIT team rose to the challenge with the development of a system—in a record amount of time—that was critical to vaccinating as many people as possible and getting life back to pre-pandemic conditions.

I want to thank this team for the tireless hours they put into this project, their creativity in imagining what this system could be, and their ingenuity in problem-solving along the way. (You know, IT folks don't always get a lot of love, so in this case where they went above and beyond the call of duty and made us proud, let's show them some love.... ;)

Our **College of Pharmacy** faculty, staff and students have played an exceptional role in both the vaccine planning and distribution workforce across the state—from Dallas to South Texas. One pharmacy student is estimated to have administered close to 1500 vaccinations alone, and one of our recent alumni was interviewed by Katie Couric about how Walmart is working to make vaccines more accessible.

In a call to action, **College of Nursing** faculty, staff and students have stepped up and gained vital experience in vaccine administration, monitoring and operations through deployment to Red Cross hubs, and the Brazos County Vaccination Hub, with approximately 300 <u>nursing students having served about 4,000 hours</u> by the end of this spring semester.

At the **College of Medicine**, from administrative tasks to recipient education and vaccinations, medicine faculty, staff and students have been volunteering with vaccine administration across the Brazos County Vaccine Hub, AP Buetel Student Health Services, and our Maroon Line Clinic vaccine sites.

And of course we can't forget to again mention the great leadership being shown by the **School of Public Health** across TAMU, the entire Texas A&M System, and the state with disease modeling, contact tracing and vaccine support. ## Colleagues,

The purpose of this email is to be sure everyone across Texas A&M Health understands on-site expectations as we begin to transition back to pre-COVID-19 operations for workplace attendance.

Based on recent System guidance, Texas A&M University sent out return to on-site work expectations earlier this week. As you are aware, the current percentage of employees in any given location on any given day will remain at 50 percent capacity through May 31, 2021.

# The expectation is that 100% of the workforce will plan to return to <u>working on-site by June 1</u>, <u>2021</u>. Pandemic conditions and business needs will continue being closely monitored and appropriate modifications announced if necessary.

There will be a **Health Science Center-wide town hall scheduled for Friday, May 14 from 1pm – 2pm** to discuss our return to campus plan and answer any questions you may have. You will receive a calendar invite soon.

## **Alternate Work Location Considerations**

- Alternate Work Location (AWL) arrangements made with supervisor and department head approval due to COVID-19 protocols will end May 31, 2021.
- The temporary delegation of authority for approval of short-term AWL requests by department heads will end May 31, 2021.
- All staff AWL requests must be submitted through the formal request process with Employee Relations. Employee Relations will be processing AWL requests in the order in which they are received. You may submit an AWL request now if you have an issue regarding returning on-site that needs consideration.
- All faculty AWL requests must be routed in accordance with <u>Standard Administrative Procedure</u> 33.06.01.M0.02, Alternate Work Location – Faculty.
- While there can be consideration given for AWL arrangements for those who may have difficulty returning on June 1 because of medical issues or family care challenges, <u>supervisors are expected</u> to exercise good judgement when it comes to granting AWL requests. Remember, the expectation is that everyone who is able will return on-site for work beginning June 1.
- For questions, please work with your supervisor and/or local HR representatives.

# **Face Covering Requirements**

- All individuals must wear face coverings in indoor public areas on campus, except where marked otherwise, even if alone (includes all non-private office or residential spaces such as lobbies, restrooms, classrooms, teaching laboratories, research laboratories, common spaces in residence halls, conference rooms, and break rooms).
- In outdoor spaces where 6-feet of physical distancing is difficult to maintain, face coverings are highly recommended.
- Currently, those who have received full COVID-19 vaccination are not exempted from this policy.

The System and TAMU are periodically reviewing the best available science and CDC guidelines, and may update based upon changing science and conditions.

- The Texas A&M Division of Research requires that everyone in a research laboratory or research building on campus wear a face covering (cloth face covering, surgical mask, etc.).
- Current limitations on occupancy of research spaces (no more than one person per sq. ft.) will
  remain in effect until August 1, 2021. Deans may approve exceptions (or if delegated, department
  heads) to accommodate undergraduate research conducted during the summer.

# **Consideration of On-site Work Policies After the Pandemic**

Texas A&M Health is just beginning to study what will be appropriate long-term remote work options after COVID19 concerns abate, taking into account what we have learned during the pandemic related to work from home opportunities. The goal is to have policies and procedures that facilitate the most productive workforce possible and add to employee satisfaction. This work is just beginning, and at this time, there is not a date certain for its completion and consideration. Any recommendations will need to be vetted and approved by the System and TAMU.

# Please remember that vaccinations for COVID-19 are safe, free to recipient, widely available, and very effective at preventing COVID-19. The best available protection strategy against COVID-19 is for you to be vaccinated as soon as possible.

The success of our efforts depends on the commitment of each employee to exercise common sense and good judgment. Texas A&M Health will continue to work with operating units to address issues related to the pandemic and any new guidance and or actions necessary to ensure a safe environment. Our top priority has been and will continue to be the health and well-being of our faculty, staff and students.

Finally, please join me in thanking our Texas A&M Health colleagues across the state for their selfless service and dedication providing health care services this past year, as well as vaccine delivery, contact tracing, testing, disease modeling, emergency dental care and other important services. Their responses have been extraordinary and represent Texas A&M Health at its best – the next generation of innovators, advocates, caregivers and lifesavers.

#### Colleagues

The Texas A&M Health Vaccine Distribution Task Force is continuing its work to provide <u>COVID-19</u> <u>vaccines</u> as quickly as possible to our faculty, staff and students involved in direct patient care (inpatient and outpatient).

These activities involve the application process to the Texas Department of State Health Services (DSHS), as well as on-the-ground coordination of vaccine rollout preparations.

In an effort to keep everyone informed with the most accurate information to date, **here's where we** currently stand:

- All three applications submitted by Texas A&M Health were approved by DSHS. These
  applications are for faculty, staff and students involved in direct patient care. The vaccine doses
  we receive as a result of these application are not available for the general public at this time.
- There are more than 2,000 Texas A&M Health faculty, staff and students who are involved in direct patient care and designated as priority 1A recipients of the vaccine.
- To date, we have received an allocation of 100 first doses of the vaccine from the state which were designated for the College of Medicine. We are hoping for a much larger number of doses next week, although still not enough to finish vaccinating all of our clinical faculty, students and staff.
- We are communicating with DSHS daily to discuss expediting allocations of vaccine inventory and advocating for greater distribution to Texas A&M Health. We have enlisted advocacy help from our leadership at the Texas A&M System.
- The applications were submitted to the DSHC by the College of Medicine and College of Pharmacy. COM vaccinated select clinical staff this week, and the COP will also play a large role in vaccinating colleagues at dentistry, medicine, nursing, and remaining clinical stakeholders across the Health Science Center as we continue to receive more first doses.
- Many College of Medicine faculty and students who were spending time in hospitals and were readily available to receive a vaccine have been vaccinated by our health system partners.
- We continue to seek opportunities for our clinical partners to provide vaccines to our clinical faculty, staff and students. That has been somewhat limited up to this point because they too have received limited supplies of vaccines.
- The vaccine we have received to date through these applications is the <u>Moderna vaccine</u>. It requires two shots, approximately 28-days apart and is shot in the muscle of the upper arm. The vaccine we expect to receive on Tuesday is the <u>Pfizer vaccine</u>, which requires a second shot in approximately 21 days.

#### Here's what we recommend:

- If you are offered a vaccine in your clinical rotation or your employment, please do not wait for the Texas A&M Health vaccine distribution unless that is how you prefer to receive the vaccine.
- If you fall into a priority category that local health systems are offering in your community and are able to sign up and receive the vaccine, please do not wait for the Texas A&M Health vaccine distribution.
- Continue to monitor email updates as information evolves, as the federal government and the DSHS are regularly updating their COVID-19 information on vaccine distribution priorities and doses available which will affect our distribution.

We are prepared to move quickly once we begin receiving additional vaccine doses from the state. We ask for your patience as we work to secure more vaccines and distribute them as rapidly as possible.

Your safety is our top concern. Information is changing daily, and we will continue to keep you as informed.

Stay safe, and thanks for all you do for Texas A&M Health.




#### Research



It was a very busy week with a lot of exciting things going on.

- I am pleased to announce that **Dr. Ray Pentecost** (Professor of Practice, College of Architecture and Director of the Center for Health Systems & Design) now has a joint appointment with our College of Medicine in our Primary Care & Population Health Department.



• The Office of Evaluation and Assessment is pleased to welcome **Dr. Kevin Kidder** back to our college as our Director of Evaluation and Assessment and Instructional Assistant Professor in the Department of Medical Education. Dr. Kidder has a PhD in Educational Psychology and Research

with a concentration in Evaluation, Statistics, & Measurement from the University of Tennessee. Dr. Kidder worked with our college for several years, and then returned to us after working at The University of Colorado School of Medicine as Assistant Director of Evaluation and Assistant Professor in the Department of Family Medicine. During his time as the Evaluation Specialist at the National Institute of STEM Evaluation and Research (NISER), he was able to help secure and serve as the external evaluator for nearly \$13 million in federally funded STEM education grants from the National Science Foundation (NSF), the National Institutes of Health (NIH), and the United States Department of Agriculture (USDA). Additionally, Dr. Kidder was nominated and accepted into the Texas A&M "Leading Others" program, and he is finishing the 5-month intensive leadership course next month. 
- Undergraduate Medical Education: Dr. Jeremy Gibson, Chair

vaccination coverage (at 2 weeks past receiving the second dose of a current approved COVID-19 vaccine).

- The Maroon Line Clinic vaccination center on the Bryan campus anticipates receiving its allotment of second doses next week to continue the vaccination series for individuals vaccinated during our initial trial in January.





### Dear COM All,

I hope you all had a good week. I have the following updates for you:

- We had our first BSWH/Texas A&M Joint Affiliation Committee (JAC) virtual meeting on Tuesday (please view presentation attached). The meeting was very productive with definitive next steps outlined. Our next meeting of this group is planned to be in person in Dallas in March.
- I would encourage any of our COM employed faculty who are interested to apply for our COM Faculty Ombudsman position (information attached). This is a great opportunity to play a key role in improving our learning environment.

### • COVID-19 updates

- Positivity numbers
  - Employees (includes staff and sponsored residents) = 32
  - Students (includes graduate and medical students, as well as undergraduate students working in our labs) = 49
- This week, our Maroon Line testing site returned to a standard testing schedule, from noon to 2 pm Tuesday and Thursday, with 200 standing appointments each day. During those two days, we tested 105 faculty, staff, and students. We had three new volunteers helping at the testing site, all of them first-year medical students.
- The <u>BCG vaccine trial</u>, led by Dr. Jeff Cirillo and Dr. Greg Neal, has screened 1,253 people and treated 269. About 100 subjects have completed the first six months of the trial, and the researchers are conducting a meta-analysis with other ongoing studies throughout the world in the hope of obtaining preliminary findings earlier.

- We are tracking multiple high-risk exposures at this time. Please remain vigilant with regards to your wellpracticed safety measures including hand-hygiene, appropriate masking, social distancing, and avoiding meals indoors or in close proximity. Together we can continue to Lead By Example as we hold the <u>Maroon Line</u>.



- For those of you who may have not seen it, the NBME/USMLE announced earlier this week they will no longer be having the **Step 2 Clinical Skills examination** (article attached).
- I am pleased to announce that Dr. Jose Florez-Arango from our COM Department of Humanities in Medicine is representing our college on the Executive Committee of the Center for Health Systems Design out of the TAMU College of Architecture. Dr. Florez-Arango will be reporting out his findings from this leadership role quarterly at our COM Executive Committee meetings.

Gary McCord, Danielle Dickey, and Terri Kurz for their presentations. We had over 40 participants and look forward to starting our complete (inpatient and outpatient) Pediatric Clerkship experience in Round Rock next month with them.


I hope you are all doing well and that you had a great week. For this week, I have the following updates:

- We received 100 Moderna vaccine doses, and by the end of today, we will have administered all of them. A system for more broad registration for individuals who are Texas A&M HSC employees and qualify for phase 1B per State of Texas DSHS guidelines (over 65 or over 18 having chronic health conditions placing them at risk for severe COVID-19 disease) will be rolled out soon based upon vaccine allocations to our center.
- Please be aware the Texas A&M System Curative testing registration site now includes collection of insurance information as per their contract with Curative, Inc. This insurance registration system is in effect for all Curative testing sites across Texas A&M including the Maroon Line Testing site in Bryan and the HSC Testing site on the Round Rock campus. Values.


### GENERAL UPDATES
