This letter is in reply to your Freedom of Information Act (FOIA) requests 2021-4111(IR#0515) seeking "All documents containing FDA's policies, procedures, and protocols for identifying individual VAERS Reports that need a rapid response and all documents concerning investigation and/or follow-up of same" and 2021-4112 (IR#0514) seeking "All documents identifying, discussing, or following-up on individual VAERS reports that need a rapid response, dated between January 1, 2020 and present date within the Office of Biostatistics and Epidemiology." Both FOIA requests are dated June 23, 2021 and were received in the Center for Biologics Evaluation and Research on June 24, 2021.
