This acknowledges your June 14, 2021, Freedom of Information Act (FOIA) request addressed to National Institutes of Health (NIH) FOIA Office. It was received in this office the same day. You requested all reports prepared and/or transmitted to the Committee on Energy and Commerce of the House of Representatives and the Committee on Labor and Human Resources of the Senate pursuant to 42 U.S.C § 300aa-27(c).

The NIH searched the NIH Office of Legislative Policy and Analysis (OLPA) and the NIH Office of the Director (OD) Office of the Executive Secretariat, and no records responsive to your request exist.
