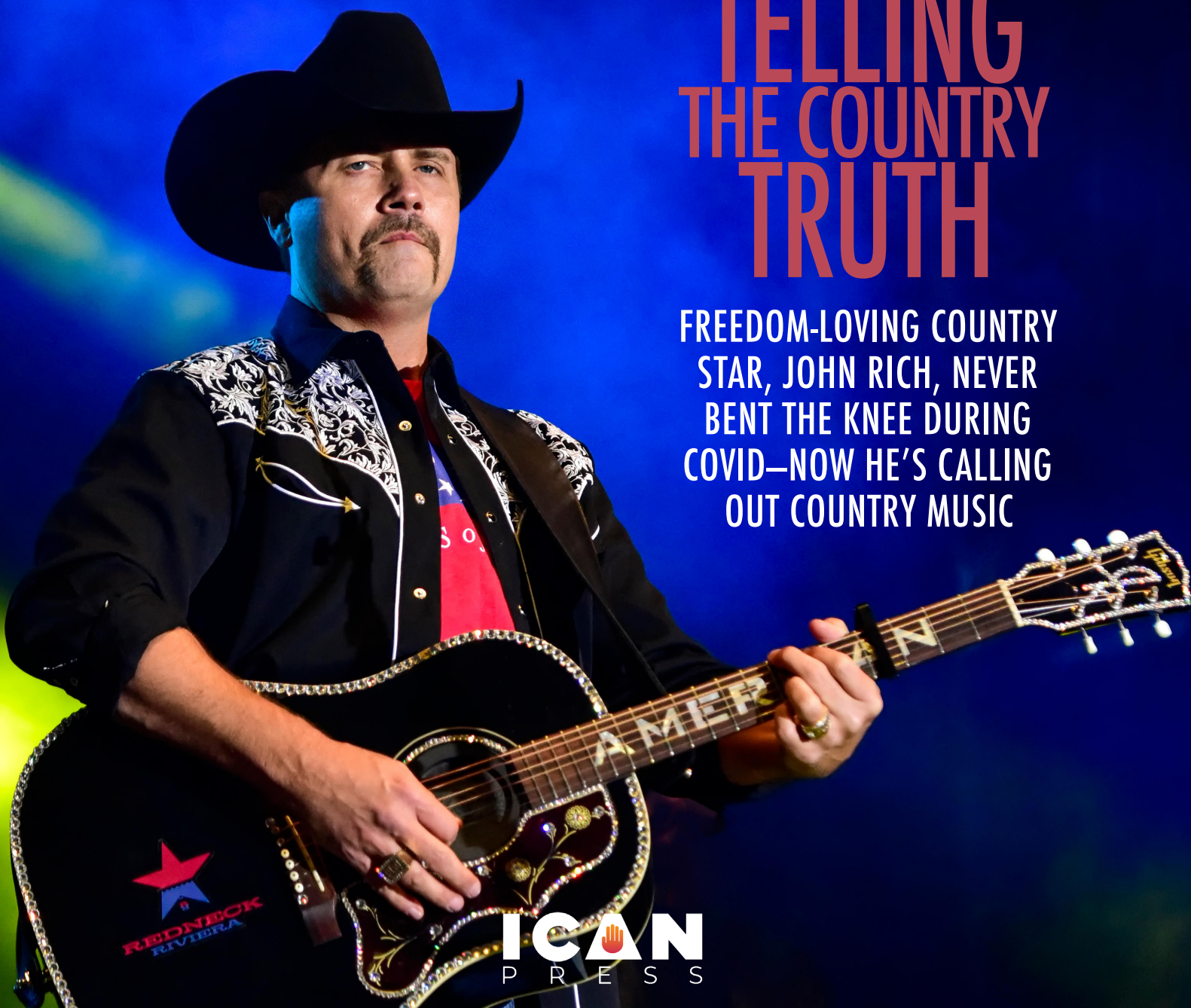

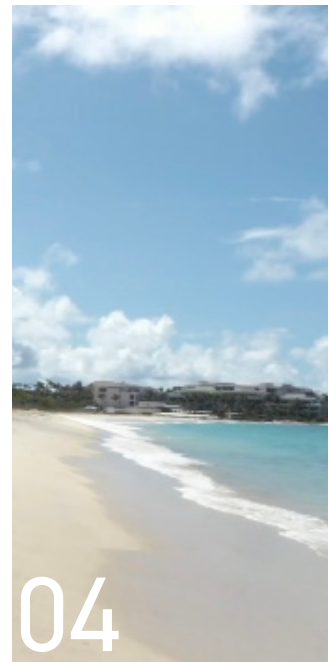
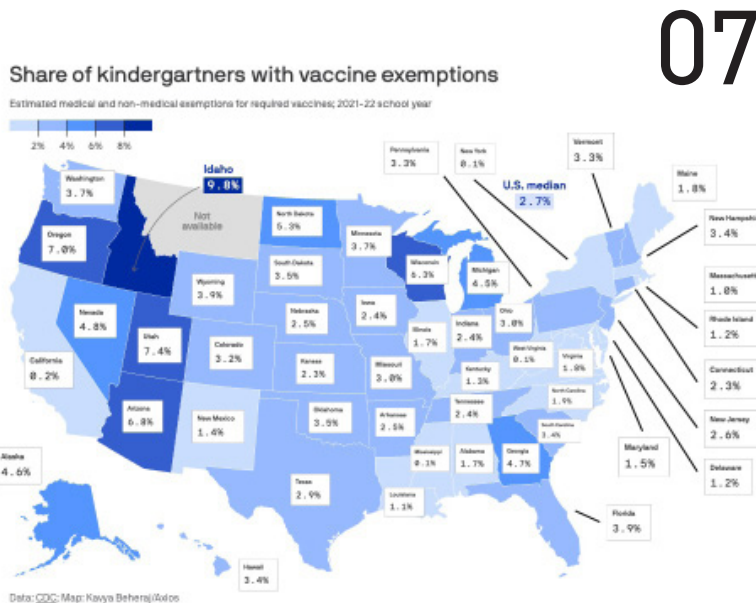

## Lonely Island: From Solitude to Solidarity

I'm one of those people that, when I travel, it's nice to find that remote beach where there's just not people crowding everywhere, you got the place to yourself. But then there's a point when maybe it's too much...

Many, many years ago, my wife and I went to the island of Anguilla on a vacation. We were living in New York City at the time, and for whatever reason, I'm not sure of the season, but when we got there, I think we were the only two people on the entire island. And so for like four days, we would sit on the beach, and no matter what direction you looked, it was like nobody lived on this island; we were all alone.

You would walk into the hotel; we were the only ones in the hotel. I would ride the scooter to the local restaurant for 15, 20 miles, sometimes all the way to the other side of the island, and we wouldn't see a single car. We would pull into the empty driveway to be the only ones in a restaurant. At that point, it starts feeling really creepy and strange, like you're in the middle of some sci-fi armageddon post-apocalyptic movie. Needless to say, it wasn't our best vacation. We made the best of it, but I realized, you know what, I do want a few people around.

Similarly, as a journalist, when you get on to a story, you don't want it crowded where you're just one of thousands of people telling the same story. Unfortunately, I guess every reporter in news has to get used to that since all they do is tell each other's stories over and over again. But you want to be the one breaking. Well, that was the case with the issue around vaccinations, which I got into when I was working at CBS on the CBS talk show, *The Doctors*. When I dove into that investigation, I essentially had to walk away from that job to make the documentary that puts me in the middle of this entire conversation, that documentary being called *VAXXED*. (For those of you that are new,

*VAXXED: From Cover-up to Catastrophe* was all about a whistleblower inside of the CDC who was saying they had committed scientific fraud on the vaccine safety studies).

Now, when I was working on that documentary, I knew I was destroying my TV career by doing it, but I kept saying to Doctor Andrew Wakefield, who was directing the film and I was working with, "Are you sure we're the only ones that have this story?" And he said, "I'm sure. There's no one else who would ever cover this story. They wouldn't be crazy enough to go near it." And it proved to be true—we were all alone.

And so when we were attacked by every newspaper, when we were kicked out of Tribeca Film Festival, we were all alone. It was cool though; we were breaking the story. But as the year goes on, you kind of want somebody else to join you on the beach after a while. You want another news organization to pick up the story.

Well, for those of you who have been with us from the beginning, in 2017, after I toured the country with *VAXXED* for a year, we started our nonprofit, the Informed Consent Action Network, and we started this show, *The HighWire*, to start broadcasting out all of the legal wins we were having with our legal team, which was the heart of our nonprofit. And thus *The HighWire* began.

And then, slowly but surely, people started entering our beach. We watched as different hosts came forward, like Tucker Carlson and podcasters like Joe Rogan and Cheryl Atkinson—who actually predates me—a lone voice in the desert. Dr. Drew has really jumped on this subject. Epoch Times came along and started covering this vaccine conversation. Now many of us are recognizing that there are lots of podcasters and lots of news agencies that are certainly calling out the COVID vaccine.



I want to tell you that in this process, all we've wanted is for more and more voices to be telling the truth, so it's really awesome to have seen the growth of this conversation. We love the competition. We love that there are other networks out there now, trying to get the story. Of course, we have a couple of aces in the hole with our science and legal team that is strategically placed around the world, but that's okay; we want everybody on board.

I say all of this because every once in a while, I do an interview with one of these groups or one of these networks—and it's great to share the wealth. It's also great to celebrate those that have joined us. As a reporter, as a journalist, and a public speaker—it's like sports or music—we deliver a really solid show. And I give a pretty dang good talk when I'm out there in public...but every once in a while, you've been playing it and playing it, you just have that moment. That one game, that no-hitter, that moment where you're just in the zone and it all clicks in a way that it never really did before, at least not on that set of topics.

That actually happened fairly recently—at least I felt like it did—in an interview I did with Jan Jekielek over at Epoch Times. We were all at FreedomFest and he asked if I would come over after my speech, which I had just given on the weaponization of compassion. And he said, "I'd love to cover that topic," so we sat down and talked. Jan is an awesome, talented interviewer, and I love his show, American Thought Leaders, so it was an honor to be a part of it. And I think part of it was the questions he asked, but also of all the different ways that I've answered these questions, I felt like I really wanted to nail it to the wall this time. I think it may be one of the best interviews



I've ever done, especially for many of you out there who are brand new to this discussion, who maybe joined *The HighWire* recently or just today, and have questions about the vaccine program.

And the one question that's really at the heart of all of it is why? Why would anybody lie about safety testing? What would be the advantage for regulatory agencies to not just make sure it's tested? Why would they tell lies to the media? Why would they keep doctors in the dark? That why, or the motive, if you will, if it was a legal case, what motivates that cover up?

That's what I think is nailed in this interview and this conversation. So for those of you who are brand new, or those who have been watching for a long time but would love a really concise description, for those who are asking the question—why would they lie? Here is why they lie—

# MISSISSIPPI'S RELIGIOUS EXEMPTION FOR SCHOOL CHILDREN NOW PERMANENTLY SECURED!

## WHAT YOU NEED TO KNOW:

- ICAN's Mississippi lawsuit established a permanent injunction, enabling families to seek religious exemptions for school vaccinations, setting a legal precedent for similar cases.
- Mississippi has started accepting requests for religious exemptions. Instructions for the process are available on the State Department of Health website.
- The court ruled that Mississippi law violated the First Amendment by favoring secular medical exemptions over religious exemptions for school-mandated vaccines.
- **Key Term** | Legal precedent: A past court decision that serves as a rule or guideline for similar cases in the future.

On August 29, ICAN's attorneys, led by ICAN's lead counsel Aaron Siri, received the welcome news that the judge in their Mississippi lawsuit converted the previously-issued preliminary injunction regarding religious exemptions into a [permanent](#) injunction! This means that families in Mississippi can take a deep breath and rest assured that they will continue to have the option of requesting a religious exemption for vaccination for their children to attend school.



Mississippi has already started accepting requests for religious exemptions and [instructions for the process](#) are now posted on the State Department of Health website.

ICAN secured this [historic and critical win](#) back in April and we have heard from families in Mississippi—and across the nation—who are overjoyed to see religious freedom upheld as a First Amendment right.

As the Court's thorough and extremely [well-reasoned Opinion](#) explained, Mississippi law violated the First Amendment because

it provided a process for parents to obtain secular medical exemptions, but not religious exemptions, to mandated school vaccines. It therefore unconstitutionally favored similar secular conduct (medical exemptions) over religious conduct (religious exemptions).

This game-changing win has laid the groundwork for future challenges in the five other states that similarly allow medical but not religious exemptions to school-mandated vaccines. ICAN intends to support every one of those challenges brought by its legal team in our ongoing

2012 to 2.6% in 2019. It has stayed at 2.5% or higher since 2020, coming in at 2.7% in 2022, the latest year for which data is available."

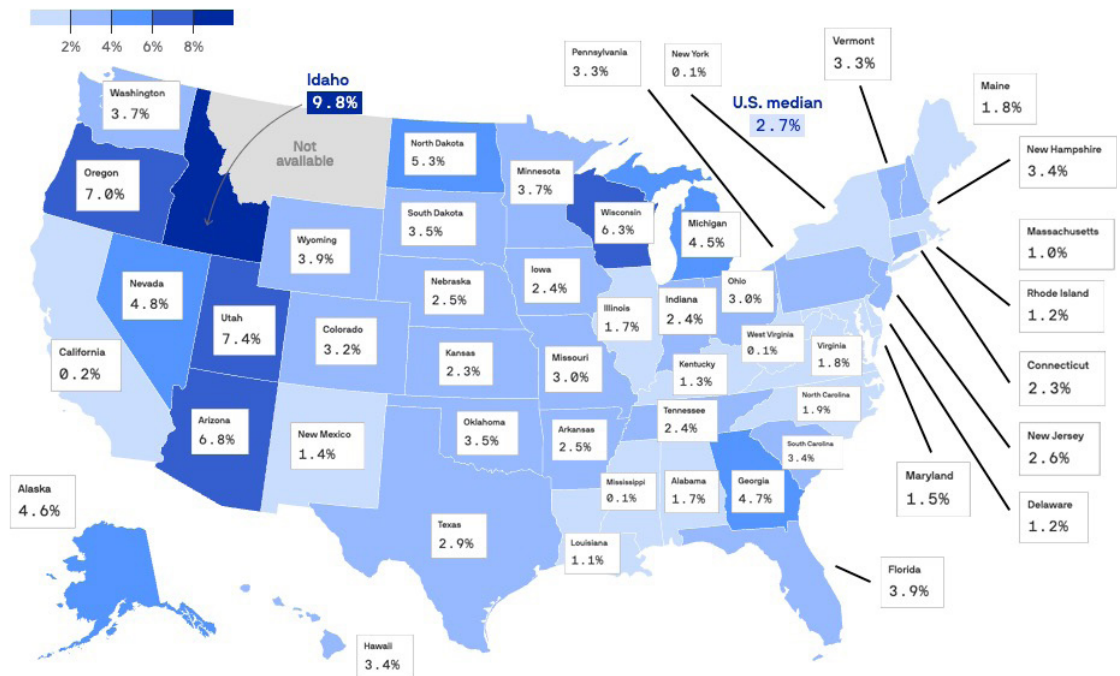

# PFIZER CLINICAL TRIAL DATA ERRORS REVEALED IN SEPTEMBER BATCH OF DOCUMENTS

As you know from prior [updates](#), the attorneys who represent ICAN also represent the plaintiff in a lawsuit against the FDA to obtain [Pfizer's COVID-19 vaccine documents](#). After a historic win, the FDA was forced to produce tens of thousands of documents every month.

The [September batch](#) covers a range of information, including some interesting correspondence between FDA and Pfizer as the trial data was purportedly being validated by FDA:

## CORRESPONDENCE

[Data validation report summary and subsequent follow-up with Pfizer](#) – This chronological report summarizes FDA's review of the trial data and its request to Pfizer for missing data.

[Information request email from FDA to Pfizer](#) – This email includes a request for "missing immunogenicity data," also mentioned in the summary report above.

[A death and severe adverse reaction narrative summary](#) – This report with nearly 3,700 pages includes details of deaths and serious adverse events in the trial with "narrative comments" on some events.

## CASE REPORTS

[A 49-year-old male](#) was **hospitalized with a myocardial infarction** one week after receiving his first dose. His only reported health issue prior to that was seasonal allergies. The event was attributed to "undiagnosed obstructive CAD [coronary artery disease]." The report then listed coronary artery disease as a separate adverse event and nonsensically attributed it to "CAD." This individual got his second dose five months later and the reason for the delay was "fever or acute illness."

[A 66-year-old female](#) was **hospitalized with a pulmonary embolism** two months after her second dose. She had a health history that included migraines, seasonal allergies, hepatitis B, and mitral valve prolapse (a non-serious heart condition). The cause of the adverse event was listed as "HRT [hormone replacement therapy] and prolonged immobilization."

## ERRORS

Nine Excel files listing of data validation errors – Download the [full production files](#) to view. These spreadsheets were generated by FDA and contain trial data errors organized into various categories. It is unclear how many of these errors were later corrected by Pfizer. [One of the Excel spreadsheets](#) summarizes data errors on its "Overview" tab including:

8.4% of adverse events have neither severity nor toxicity grade populated

24.3% of clinical events are potential duplicates

22.9% of subjects are either missing a lab test or baseline value

## ICAN DIRECTS ITS ATTORNEYS TO DIG INTO THE PLANS FOR CENTRAL BANK DIGITAL CURRENCY ANNOUNCED AFTER G20 SUMMIT



Very recently, members of the G20 summit, including President Biden, met in New Delhi and, afterwards, released a declaration with some concerning resolutions. A section on "[Central Bank Digital Currency](#)," states:

"We welcome discussions on the potential macro-financial implications arising from the introduction and adoption of Central Bank Digital Currencies (CBDCs), notably on cross-border payments as well as on the international monetary and financial system. We welcome the BIS Innovation Hub (BISIH) Report on Lessons Learnt on CBDCs and look forward to the IMF

Report (International Monetary Fund Report) on potential macro-financial implications of widespread adoption of CBDCs to advance the discussion on this issue."

Of note, it's fairly clear which way the [BIS Innovation Hub](#) Report will turn out given that its website states that it "develops public goods in the technology space" and, in 2023, "will increase its focus on improving payments systems and experimenting with central bank digital currencies (CBDC)."

Another section of the G20 declaration, titled "[Fostering Digital](#)

[Ecosystems](#)," states that the G20 members "resolve to deploy all available digital tools and technologies and spare no effort in fostering safe and resilient digital ecosystems" by, among other things, "[w]elcom[ing] the establishment of the Global Health Initiative on Digital Health (GIDH) within a WHO-managed framework to build a comprehensive digital health ecosystem in compliance with respective data protection regulations."

The Global Initiative on Digital Health is a "WHO managed network of stakeholders organized to facilitate the implementation of the Global Strategy on Digital Health 2020-2025," the goal of which is to "improve health for everyone, everywhere by accelerating the development and adoption of appropriate, accessible, affordable, scalable and sustainable person-centric digital health solutions to prevent, detect and respond to epidemics and

pandemics ...." In other words, Central Bank Digital Currency and digital health passports appear to be well within reach.

ICAN has instructed its attorneys to closely follow this issue of Central Bank Digital Currency and report back with any updates.

# IN ICAN CEO DEL BIGTREE'S MASK LAWSUIT, CDC SAYS NO PLANS TO RE-INSTITUTE TRAVEL MASK MANDATE



Del's lawsuit against the CDC over the travel mask mandate has been pending ever since August 2022 after a federal judge in a related case granted the nationwide injunction preventing enforcement of the mandate. Recently, with the COVID-19 national emergency ending and with it the CDC's travel mask mandate, Del has agreed to end his lawsuit against the CDC but only after the agency has expressly promised, in writing, that it has no plans to reinstate the mask mandate.

Back in March 2022, after the White House and Congress both dropped their mask mandates, but CDC persisted in requiring masks on planes, trains, and buses, Del Bigtree [announced](#) that, with the help of ICAN's attorneys, he had filed a

[lawsuit](#) against the CDC. Watch Del's original announcement [here](#). That same month, ICAN's attorneys separately filed a similar lawsuit on behalf of 17 members of Congress.

After a federal judge in Florida instituted a [nationwide injunction](#) against enforcement of the travel mask mandate in

which ended the COVID-19 national emergency and ultimately led the Eleventh Circuit to [end the case](#) as moot—meaning there was no relief for the court to grant because the plaintiffs had already gotten what they wanted: the end of the mandate.

Now, Del is pleased to announce that as part of ending his lawsuit, the CDC [expressly agreed](#) in writing that “defendant Centers for Disease Control and Prevention has represented that it is not aware of any present intention, plans, or discussions by defendants regarding reinstating the mask mandate on aircraft.”

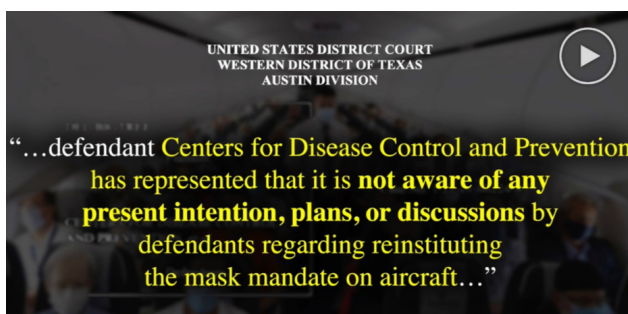
And with that confirmation from the CDC, he agreed to resolve his case against the CDC. This is a win for all.

another case, the Congress Members helped support that lawsuit by filing a brief in the appeal in that case before the Eleventh Circuit.

While everyone was waiting for a decision, on April 10, 2023, President Biden [signed](#) H.J. Res. 7,

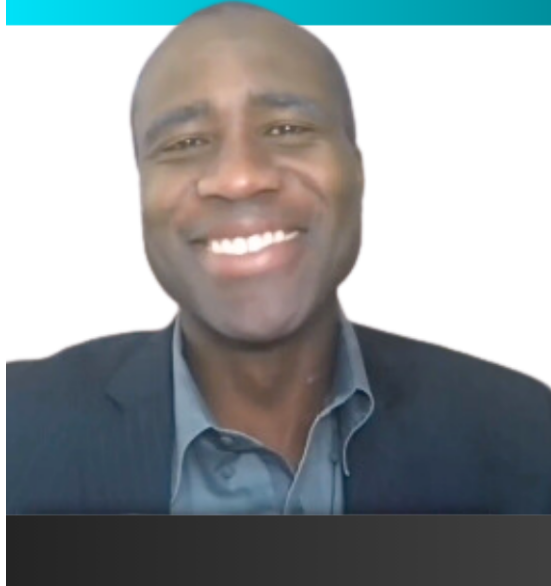

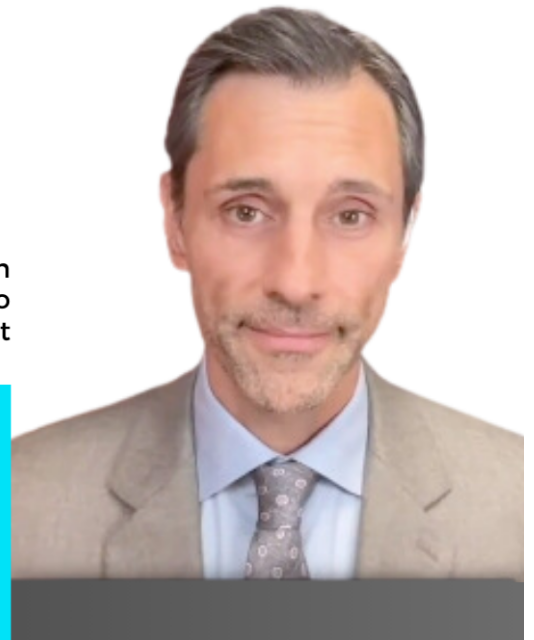

- Some grocery stores, like Natural Grocers, refuse to carry Apeel-coated produce due to concerns about exposure to the coating's ingredients.

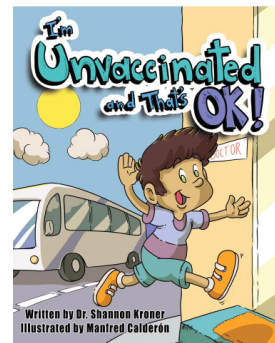
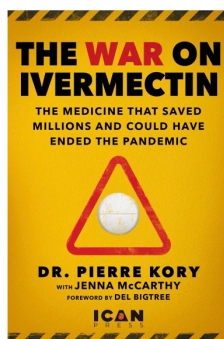

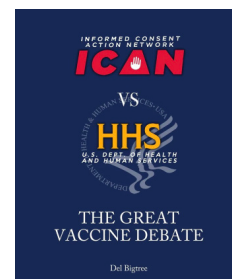
