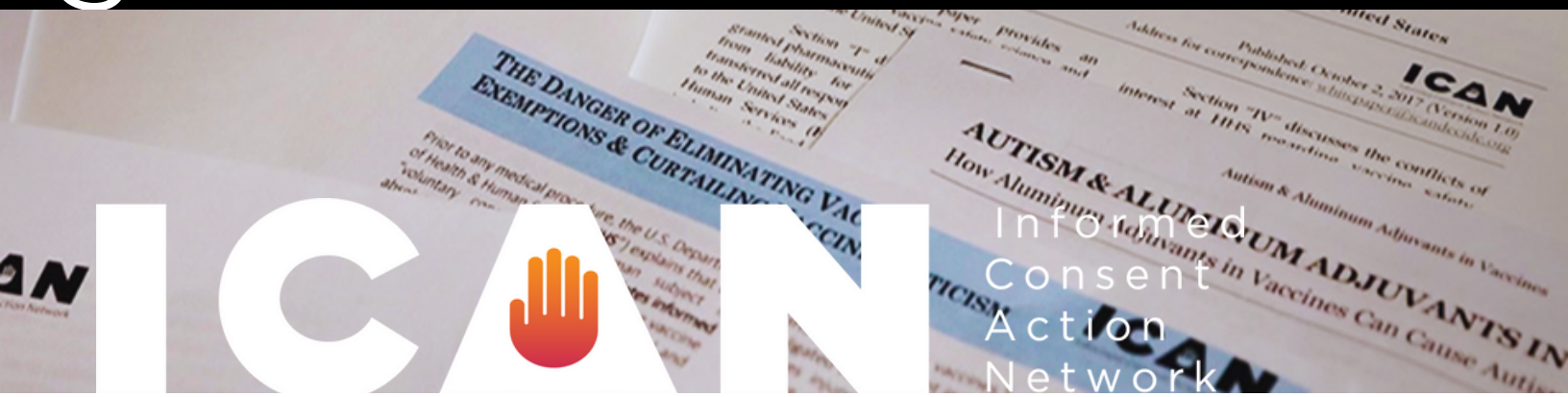

Founded in 2016, ICAN was created to educate all individuals on their right to informed consent. We believe that by holding regulators accountable through our successful legal actions, individuals will become empowered to make truly informed decisions about their health and the health of their families. Using an unprecedented legal strategy, ICAN has successfully won lawsuits against Health and Human Services, the Centers for Disease Control, the National Institutes of Health, and the Food and Drug Administration.

## Our Mission

At the Informed Consent Action Network, you are the authority over your health choices and those of your children. In a medical world manipulated by advertising and financial interests, true information is hard to find and often harder to understand. Our goal is to put the power of scientifically researched health information in your hands and to be bold and transparent in doing so, thereby enabling your medical decisions to come from tangible understanding, not medical coercion.

## What We Do

Investigate the safety of pharmaceutical drugs and other environmental interventions that pose a threat to the health of humanity, while advocating for humanity's right to informed consent. ICAN is actively involved in challenging public health agencies for greater transparency and accountability, thereby ensuring that the relevant regulatory authorities are performing their duties under the law. Our goals include fighting for parental rights, protecting children, and maintaining and promoting science-based inquiry.

## Legal Action

ICAN's legal team, led by Aaron Siri, Esq., is relentlessly devoted to fighting against mandated medicine and securing informed consent for all. This work includes endless lawsuits, petitions, appeals, formal legal demands, and FOIA requests. Mandates affecting millions of individuals have been rescinded or struck down by ICAN's legal challenges.

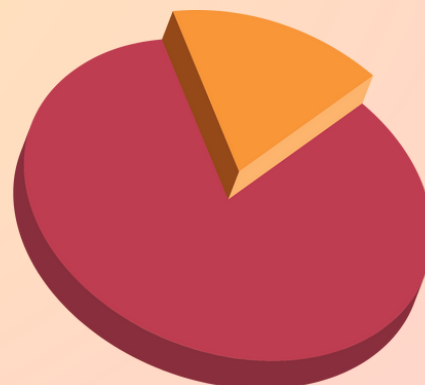

# 5 CORE FUNCTIONS OF ICAN LEGAL



## Influence Public Opinion

The FDA, CDC, and other 3-letter-institutions do not have a 'check' or watchdog over the medical products they are approving and recommending to the public - that's where we have stepped in to fill the gap. Our legal team attends almost every FDA and CDC committee hearing while also sending pre- and post-letters to ensure key individuals in these hearings have relevant facts, important perspectives, and are aware that we are watching their every move. **Over 30% of the FDA's FOIA docket are ICAN matters - we are a known force within the FDA and CDC.**

## Safeguard Civil Rights

Ultimately, our legal efforts have led to the protection or restoration of civil rights for millions of Americans and their families. **We have restored religious exemptions for over 2.9 million people and protected over 700,000 members of the military from mandates.**



## Serve as Public Health Watchdog

Judges and legislative bodies are often influenced by public opinion and cultural perceptions. We strive to influence public opinion by bringing evidence, science, and information to light. **Our legal work has been featured on Fox, Epoch Times, and other networks 12 times in 2023.**

## ICAN vs. HHS

The U.S. Department of Health and Human Services (HHS) admitted that, in direct violation of Federal law, it has **failed to provide a single vaccine safety report to Congress for over thirty years**. This acknowledgment came after eight months of stonewalling from HHS following a Freedom of Information Act (FOIA) request from ICAN. ICAN sought copies of the reports HHS was required to submit to Congress every two years, starting in 1988, detailing improvements it made to vaccine safety.

## ICAN vs. CDC

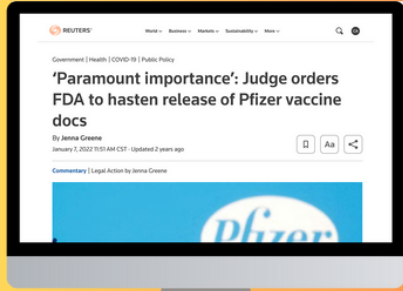
In the summer of 2019, ICAN submitted a Freedom of Information Act (FOIA) request to the CDC for "All studies relied upon by CDC to claim that the DTaP vaccine does not cause autism." ICAN also submitted this same request for HepB, Hib, PCV13, and IPV vaccines, and additionally requested that the CDC provide studies to support its claim that the cumulative exposure to these vaccines during the first six months of life does not cause autism. Despite months of demands, the CDC **failed to produce a single study** in response to these FOIA requests. ICAN was therefore forced to sue the CDC in federal court, where the CDC finally entered into a stipulation, signed by a federal court judge, that made clear it **cannot scientifically support its claim that these vaccines do not cause autism**.

## ICAN vs. NIH

The vaccines on the CDC's childhood vaccine schedule given to babies during the first six months of life include over **3,500 mcg of aluminum adjuvant**, a known neurotoxic substance which can damage nerves and kills cells. Given the foregoing concern, a FOIA request was submitted to the National Institute of Health (NIH) requesting "copies of any human or animal studies involving the subcutaneous or intramuscular injection of aluminum adjuvant relied upon by the NIH to establish the safety of injecting infants and children with aluminum hydroxide, aluminum phosphate or amorphous aluminum hydroxyphosphate sulfate." After months of extensive search, **NIH finally conceded that "no records responsive to your request were located."**

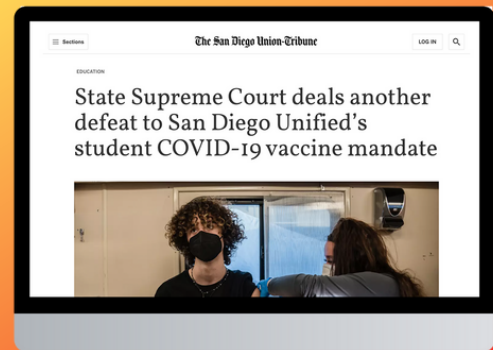


## PFIZER DOCUMENTS RELEASE

ICAN attorneys obtained a court order forcing the FDA to produce all of its data on Pfizer's COVID-19 vaccine for those 16 years and older at a rate of 55,000 pages per month, as opposed to the 75 years FDA sought.

## SCHOOL MANDATE STRUCK DOWN

In a historic win, an ICAN-funded lawsuit struck down a COVID-19 vaccine mandate enacted by the San Diego Unified School District.



## D.C. PARENTAL CONSENT CASE

ICAN-funded lawsuit halted a law allowing 11-year-olds to be vaccinated without parental consent.



## ICAN OBTAINS VSAFE DATA

ICAN obtained a court order requiring the CDC to release V-Safe data that includes over 137 million health entries from recipients of COVID-19 vaccines.

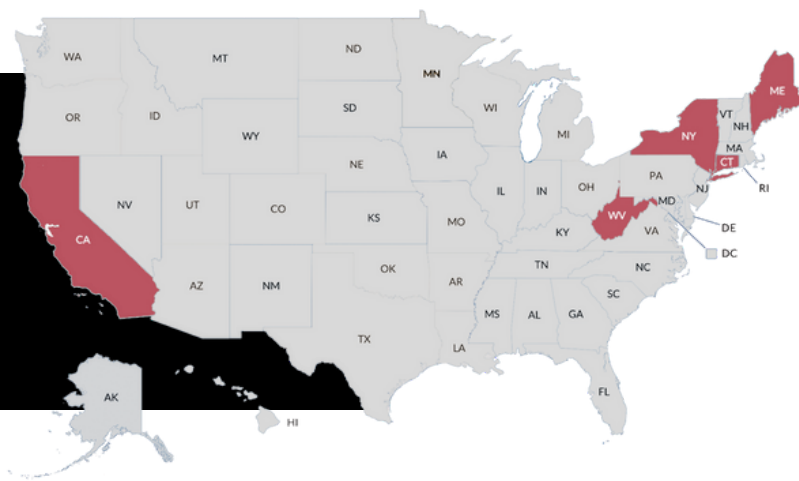

On April 17th, 2023, ICAN's attorneys secured a historic and critical win when a federal judge ruled that **the First Amendment requires Mississippi to offer its residents a religious exemption for their children to attend school without one or more state-mandated vaccines.** This win lays the groundwork for future challenges in other states that similarly allow medical but not religious exemptions.

On the heels of the historic Mississippi win, which secured a religious exemption from vaccination for K-12th graders, **ICAN announced that its attorneys, led by Aaron Siri, are currently litigating the same in both West Virginia and New York.** ICAN is also funding upcoming lawsuits to secure religious exemptions in the remaining holdout states (Maine, California, and Connecticut)! This will cover every U.S. state in an attempt to secure a religious exemption from vaccination for every K-12 student across our nation like we just did in Mississippi.



# 9 LEGAL IMPACT 2023

ICAN supported unvaccinated healthcare workers in New Jersey. **ICAN's attorneys wrote a legal demand to New Jersey Governor Philip D. Murphy demanding that he end the requirement that unvaccinated healthcare workers undergo weekly COVID testing.** Just days later, Governor Murphy rescinded the testing requirement.

We helped abolish the Travel Ban of unvaccinated visitors to the US. **The Federal Government dropped its COVID-19 vaccine travel mandate for non-citizens on the same day it was due to file a response in a lawsuit brought by ICAN's attorneys.** This was a significant step in returning the right to bodily autonomy to all.

We uncovered truths about the FDA's safety monitoring systems. Throughout the pandemic, the FDA constantly assured the public of how "safe and effective" COVID-19 vaccines are and assured us that it was carefully monitoring for safety signals and rapidly investigating any concerning adverse events. **ICAN's attorneys therefore demanded the FDA produce documents regarding VAERS reports that required a "rapid response," as called for in the FDA's own safety protocol.** The FDA could not produce a single document in response!

Each month as more Pfizer clinical trial data is released, ICAN scours the data and reports on findings. **We continue to uncover suspicious hospitalizations and deaths in the clinical trial data.**

We uncovered data presented in a CDC meeting showing that for the final week of July 2021, **fully vaccinated individuals made up an estimated 73% of COVID-19 cases and 63% of COVID-19 hospitalizations in the 65+ age group.** It also showed that infection rates 5-6 months post-vaccination were twice as high as infection rates 3-4 months post-vaccination. CDC kept this data from everyone, including FDA.

ICAN's legal work

ICAN is supporting a lawsuit, filed against the federal entities charged with administering CICIP and on behalf of eight severely COVID-19-vaccine-injured individuals and React19, to **strike down the immunity to liability and the Countermeasures Injury Compensation Program (CICIP) provisions of the PREP Act** because they violate the constitutional rights of those injured or killed by a COVID-19 vaccine. If this suit is successful, **the relief sought will apply to all COVID-19 vaccine-injured individuals in the U.S.**

**We obtained the Moderna COVID-19 vaccine lot data and are helping to obtain the Moderna data FDA relied upon to license the vaccine.** After a full year of legal battles, our attorneys obtained Moderna vaccine lot, dose, and distribution information. As with the Pfizer lot data, this data will help enable analyses to determine if certain lots were "hot lots" that resulted in more severe and/or numerous adverse event reports.

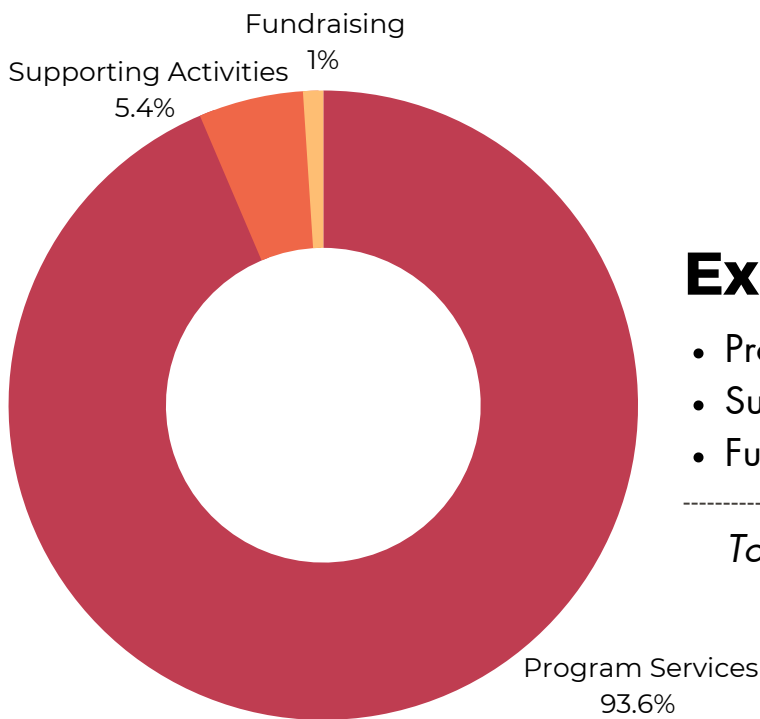
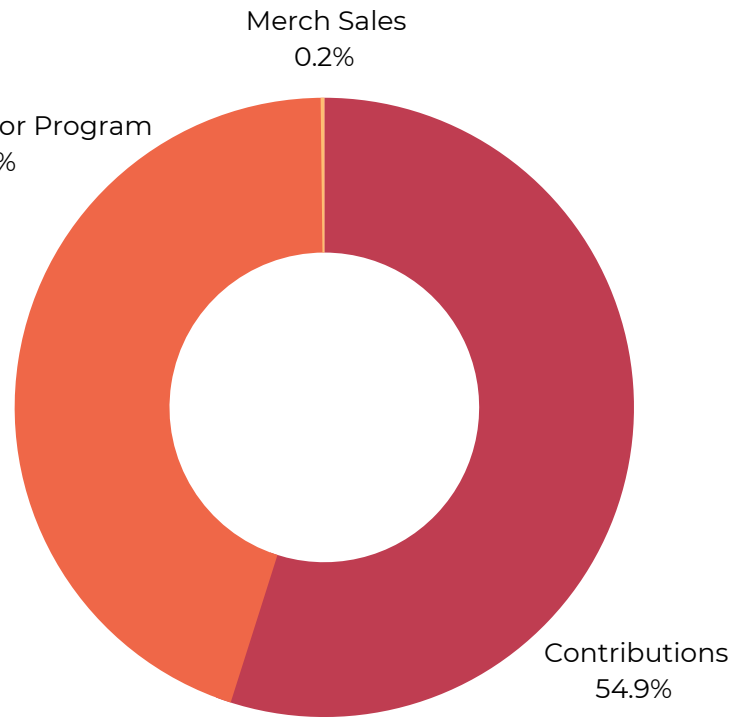
