



BREAKING: LAWSUIT FILED AGAINST ASTRAZENECA FOR MOTHER SERIOUSLY INJURED IN ITS COVID-19 VACCINE TRIAL

WHAT YOU NEED TO KNOW:

- Brianne Dressen, cofounder of REACT19, is suing AstraZeneca for breach of contract after suffering severe neurological harm during their U.S. COVID-19 vaccine trial.
- AstraZeneca's consent form promised to provide or cover the costs of medical treatment for research injuries.
- Despite being diagnosed with "Post Vaccine Neuropathy" by the NIH, AstraZeneca ignored Dressen's pleas for aid and refused necessary support.
- They offered her \$1,243.30 in exchange for releasing the company from further financial responsibility, which she declined.

The attorneys that regularly represent ICAN filed a lawsuit against COVID-19 vaccine manufacturer AstraZeneca on behalf of Brianne ("Bri") Dressen, co-founder of REACT 19, who suffered severe neurological harm while participating in AstraZeneca's U.S. COVID-19 vaccine clinical trial. AstraZeneca is being sued for breach of contract after callously ignoring Bri's pleas for aid. This is likely the first case of its kind.

Bri was a healthy and active 39-year-old wife,



mother, and preschool teacher when she signed up for the AstraZeneca clinical trial and received her first dose of the company's COVID-19 vaccine on November 4, 2020. Shortly after her shot, she experienced tingling and prickling in her arms, blurred vision, headache, sound sensitivity, tinnitus, nausea, and vomiting. Bri's condition continued to worsen as time went on, baffling her doctors, and yet AstraZeneca refused to provide any information, medical referrals, medical care, or finances to assist with her treatment.

Bri was eventually diagnosed with "Post Vaccine Neuropathy" by none other than the National Institutes of Health (NIH). This post-vaccine neuropathy caused chronic inflammatory demyelinating polyneuropathy (CIDP), a condition which has caused constant, abnormal, and painful sensations with which Bri has suffered, including the feeling of being repeatedly and constantly electrocuted.

This leaves Bri in constant pain and has resulted in her inability to work or fully care for her children for the past three-and-a-half years.

As ICAN supporters well know, the PREP Act prevents vaccine recipients like Bri from suing COVID-19 vaccine manufacturers for their injuries. However, AstraZeneca's informed consent form, which Bri signed in order to participate in the trial, promised to "provide medical treatment or refer you for treatment" and "to cover the costs of research injuries." Despite this, AstraZeneca ignored numerous requests for support before finally offering Bri the laughable sum of \$1,243.30—a minuscule fraction of the medical bills, lost wages, and other expenses that she and her family had incurred.

Worse, AstraZeneca conditioned its offer on Bri agreeing to release the company of all further financial responsibility for her care! Bri refused to accept this deal.

Fortunately, the attorneys that regularly represent ICAN have stepped in and filed a breach of contract suit to hold AstraZeneca accountable for the promises it made to Bri. They have requested a jury trial and look forward to holding AstraZeneca responsible.

Rest assured, ICAN will follow the case closely as the attorneys hold AstraZeneca's feet to the proverbial fire and demand justice for Bri!

ICAN'S ATTORNEYS SECURE EXEMPTION FOR AIR FORCE SERVICE MEMBERS' CHILDREN

WHAT YOU NEED TO KNOW:

- An Air Force couple's request for a religious exemption from vaccination for their children's on-base daycare was denied.
- ICAN works to ensure the Department of Defense respects service members' First Amendment rights and religious freedoms.
- With ICAN attorneys' help, they successfully appealed the decision within a week.

Recently, a husband and wife who were both Air Force service members requested a religious exemption from vaccination for their children so that they could attend on-base daycare activities. The Air Force denied their request and one of their children was set to be kicked out of the center within a week.

After the service members reached out to ICAN attorneys, immediate action was taken to ensure that



the Air Force understood their requirement to abide by Department of Defense policy and the Religious Freedom Restoration Act (RFRA). Attorneys worked decision. Less than a week after it was submitted, their appeal was granted, and their children can now attend on-base daycare while having their religious

with the parents to submit an appeal requesting reconsideration of the initial freedoms honored. ICAN's goal was to not only help this family but remind the Department of Defense of its duty to respect the First Amendment and the rights of service members. As Department of Defense Instruction (DoDI) 1300.17 1.2. e. states "DoD Components will normally accommodate practices of a Service member based on sincerely held religious belief..."

Further, the RFRA requires the government to make these determinations using a case-by-case analysis, and not a generalized assessment.

When reminded of these regulations and laws by ICAN's attorneys, the Air Force reversed the denial. Every success is celebrated by ICAN, but it is especially gratifying when we are able to assist our United States military members and help defend their rights. And we hope the Department of Defense has learned that it cannot violate the religious freedoms of its service members with impunity.

DR. SHERRI **TENPENNY** | EP 370

Osteopath and pioneer in the vaccine safety movement, Sherri Tenpenny, DO, describes her two-year battle with the Ohio State Medical Board, which led to a temporary suspension of her medical license, after speaking on the dangers of the COVID-19 vaccines at a state health committee meeting.

WHAT TO KNOW

- Dr. Tenpenny received letters from the state medical board requesting a psych eval after speaking out about COVID-19 and vaccines.
- Her medical license was suspended due to state medical board actions, preventing her from practicing medicine.
- She emphasized the importance of providing vaccine-related information for fully informed decisions, clarifying that she never tells people not to vaccinate.
- Despite cooperating with the board, she faced potential fines and indefinite suspension. After preparing a writ of mandamus to prompt a board investigation, the state medical board eventually reversed its decision, unanimously reinstating her license.





- Chris Cuomo, previously supportive of vaccines, now advocates for a "9/11-style commission" for vaccine injury accountability.
- A Cleveland Clinic study shows the 2023-2024 COVID vaccine formulation may increase the risk of COVID-19 among vaccinated individuals.

WHAT TO KNOW


- Dr. Andrew Wakefield, director of *Protocol 7*, and actress Emmy Robbin joined Del to discuss the film which is in theaters now.

- Emmy Robbin is also a doula whose work aligns with her advocacy for natural health choices.






