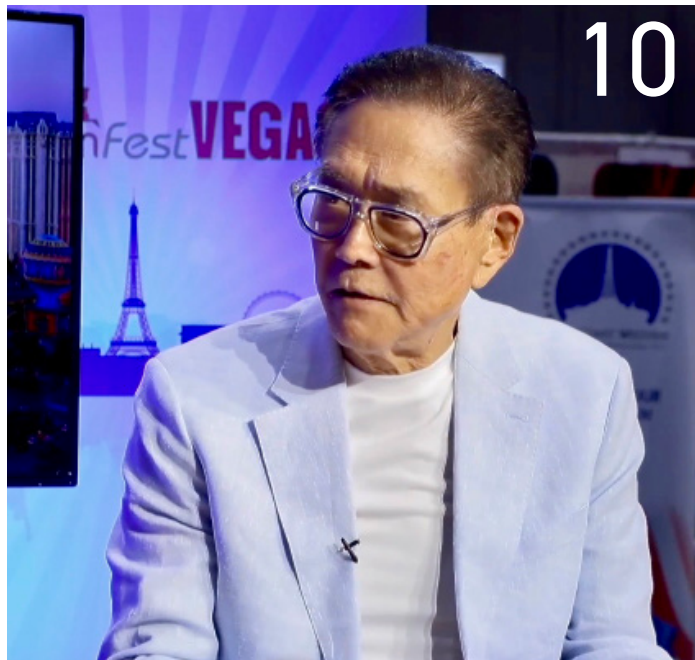
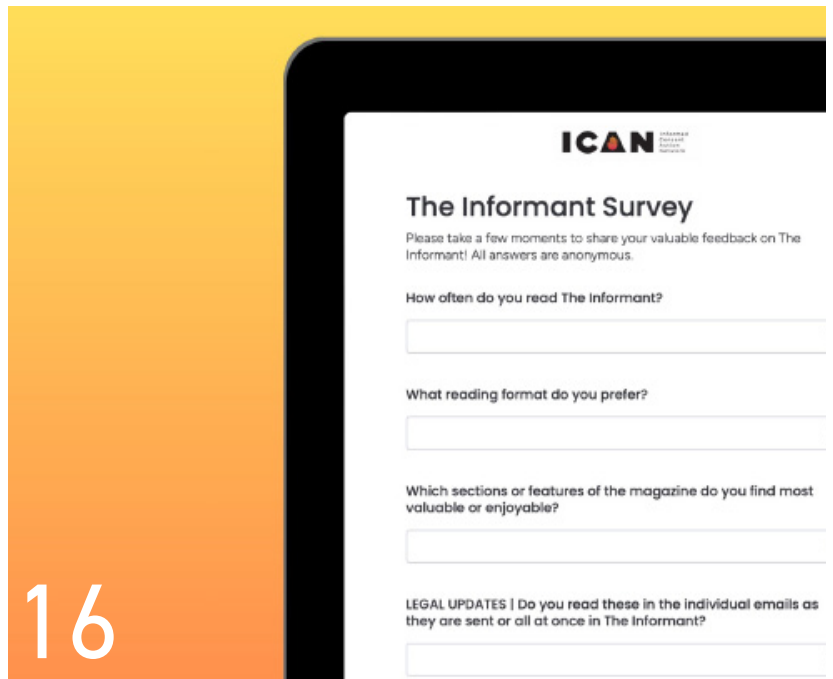

SELF-SPREADING VACCINES COMPANY REBRANDS AFTER ICAN RAISES ALARM

WHAT YOU NEED TO KNOW:

- ICAN's legal team uncovered U.S. government funding for the development of self-spreading vaccines.
- These vaccines are engineered to modify immune systems and spread from person to person.
- *Autonomous Therapeutics, Inc.* has since rebranded and altered its messaging.
- ICAN has filed over 30 FOIA requests and three lawsuits to uncover government involvement in these technologies.



Earlier this year, *The HighWire* broke an [alarming story](#) on how the U.S. government is funding the development of "self-spreading vaccines." Through FOIA, ICAN's legal team discovered two companies that are engineering viruses designed to "hijack" our God-given immunesystems, force our cells to become factories of these "therapies," and spread person-to-person.

ICAN sounded the alarm on the grave, and potentially irreversible, threat this technology

would pose to our bodily autonomy if released. The segment received record-breaking attention and it appears our coverage, [FOIA requests](#), and the subsequent public backlash have struck a nerve.

One of the two companies, *Autonomous Therapeutics, Inc.*, has rebranded itself since the segment aired. The company website [used to brag](#) about how it is building "inhalable," "artificial immune systems" with its "encrypted RNA" vaccines and therapeutics. Now, the company [claims](#) it is simply developing

"precision medicines" that are "disease-activated."

Rest assured, we are not fooled by this pathetic attempt at damage control and ICAN has directed its legal team to continue closely monitoring *Autonomous Therapeutics* and the many other companies and federal agencies developing concerning biotechnology.

ICAN's tireless legal team has filed more than 30 FOIA requests demanding answers about the push for self-spreading vaccines. So far, this has included filing three lawsuits against agencies that have refused to comply with our requests. The American people deserve to know whether their government is using their tax dollars to extinguish their right to informed consent.

LITANY OF SUFFERING CONTINUES IN MODERNA CLINICAL TRIAL DOCUMENTS

WHAT YOU NEED TO KNOW:

The Moderna documents [released](#) in April and May 2024 consist mostly of patient case report files submitted to FDA by Moderna. We hope impartial scientists will carefully review and publicize their findings with regard to these case reports.

ICAN will continue to shine a spotlight on these trials and work to make every page available to the independent scientific community.

The latest batches of Moderna COVID-19 vaccine clinical trial documents continue to show that participants had a significant number of medical emergencies—including death, heart surgery, cancer, and miscarriage—in the days and months following vaccination. ICAN OBTAINS RECORDS SHOWING THE U.S. MILITARY SPRAYS TOXIC PESTICIDES IN U.S. RESIDENTIAL AREAS

WHAT YOU NEED TO KNOW:

- ICAN's legal efforts revealed that the U.S. military conducts nighttime aerial spraying of dangerous chemicals over residential areas.
- The chemicals include the highly toxic pesticide Naled, which is linked to severe health effects, such as headaches, nausea, and respiratory issues.
- Flight records show systematic spraying over populated area in 9
- ICAN is challenging these practices, seeking EPA transparency and scientific evidence on pesticide safety.

Concerned parents tirelessly defend their children from toxic chemicals coming from seemingly every direction—in food, cleaning products, furniture, toys, etc. But how many of us have considered whether chemicals are being sprayed from our skies while we sleep?

ICAN's legal team recently [obtained records](#) through FOIA showing that the U.S. military sprays dangerous chemicals from airplanes over *residential areas*. The spraying is usually done at night (when insects are most active), so you likely wouldn't realize that your home had been sprayed. It's done by the U.S. Department of Defense (DOD), which has



a specialized unit that is dedicated to spraying large areas of land (5,000 acres or more).

According to [its website](#), this military unit "conducts as many as 25 recurring annual missions on 12 military installations in nine states, and in some cases, *over communities surrounding these DoD areas.*" It uses [airplanes](#) that "are specially modified with spray arms and the MASS [Modular Aerial Spray System], which can carry a total of 2,000 gallons of insecticide, herbicide or dispersant. The agent is then disbursed out of spray bars under each wing, in 30-micron droplets."

The documents also include the unit's flight records which show where these military planes systematically sprayed, including large, populated areas in Texas, Louisiana, Virginia, Parris Island in South Carolina, and the City of Burlington in North Dakota, just to name a few.

The records also show that the pesticides killed mosquitos that were inside boxes [inside of buildings](#). Incredibly, one flight path shows the planes *intentionally avoided spraying areas with bald eagle nests*. So, if the chemicals being sprayed are too dangerous for baby eagles, how are they affecting us?

Lead Counsel, Aaron Siri, Esq., lays out the details here:



These documents further reveal that the unit has sprayed more than 20 chemicals, mostly containing the highly toxic organophosphate pesticide Naled, which kills insects by destroying their central nervous system.

In humans, symptoms of pesticide poisoning include headaches, muscle twitching, nausea, diarrhea, vomiting, respiratory depression, seizures (especially in children), and loss of consciousness. Frighteningly, even if you don't live in areas being sprayed, you may be exposed to Naled through your food, drinking water, and even clothing. In June 2020, the EPA recognized that food and drinking water are "[anticipated exposure pathways](#)" because Naled is sprayed on crops (almonds, broccoli, grapes, strawberries, cotton, and more), used in public pest control measures, and reaches groundwater sources of drinking water.

Rest assured that ICAN's legal team is digging into this issue and has already sent multiple legal requests to the EPA—the agency tasked with protecting the air we breathe, the water we drink, and the soil we grow our food in—requesting scientific proof that the pesticides being sprayed *do not* pose a threat to our health or to the environment.

WORLD'S LEADING VACCINOLOGIST, STANLEY PLOTKIN, JUST CAPITULATED REGARDING THE LACK OF VACCINE SAFETY!

WHAT YOU NEED TO KNOW:

- In a recent paper, Dr. Stanley Plotkin acknowledges vaccines lack sufficient safety studies. Proposed solutions include thorough post-authorization safety studies and enhanced monitoring.



We are [winning!](#) After decades of Dr. Stanley Plotkin and his vaccinologist disciples insisting vaccines are the most well studied products on the planet, they just penned an article admitting precisely the opposite.

They just admitted vaccines are not properly studied—neither pre-licensure nor post-licensure. They admitted, for example, “prelicensure clinical trials have limited sample sizes [and] follow-up durations” and that “there are not resources earmarked for postauthorization safety studies.”

That is an incredible reversal. They are now admitting what ICAN has, with your support, been pounding the ground for years, in courthouses, legislative houses, national news, etc.

But let's not be fooled! They are not saying this because they care about vaccine safety. They are saying it because they need to try and control the narrative. Dr. Paul Offit said, “I think

we should be proud of vaccines as arguably the safest, best tested things we put in our body.”

For decades, parents of vaccine injured children, vaccine injured adults, and other stakeholders contested these claims only to be shunned and attacked by the medical community and health agencies.

In 2018, our lead attorney, Aaron Siri, had the unprecedented opportunity to [depose the architect of our vaccination program](#) and the Godfather of Vaccinology, Dr. Plotkin, and lay bare the evidence that showed what these authors are now finally admitting about the utter lack of vaccine safety trials and studies.

Afterwards, Dr. Plotkin [went on a tirade](#), making demands that FDA add “missing information on safety and efficacy” in vaccine package inserts and that CDC exclude harms from its Vaccine Information Sheets, “lobbying the Gates Foundation to support pro-vaccine organizations,”

working to have WHO list vaccine hesitancy as a global threat, lobbying AAP, IDSA and PIDS to “support training of witnesses” to support vaccine safety, etc.

The problem is, there is no safety data to add to the FDA package inserts, and hiding harms by removing them from CDC inserts doesn't make them go away. Parents and other adults don't simply stop believing what they have seen with their own eyes because CDC, WHO, the Gates Foundations, etc., won't acknowledge them, or worse, attack them.

That brings us to the present where their only option is to try and co-op the truth they have lied about for decades by now admitting that the studies to show vaccines are safe do not exist. But in making that admission, they conveniently fail to admit that for decades they lied, gaslit, and defrauded the public by claiming that vaccines are probably the most thoroughly safety tested products on the planet. While their article admits the studies have not

been done, they write in the same breath that serious vaccine harms are “rare.” But if the studies have not been done, how do they know that? The answer is, they don't, and they don't care to know the truth. They also ignore the mountain of [studies and data](#) which already exist that clearly show serious vaccine [harms](#).

If they are really interested in the truth about what injuries vaccines cause and the rate at which these injuries occur, then they should welcome convening a bipartisan panel that could first review all the very concerning studies and hard data that already exist on this topic so we could design additional studies together and have them run in the open so everybody has to live with the result.

Plotkin and company should welcome studies that show vaccines have not contributed to the rise in chronic childhood disease. The reality is that studies showing vaccines contribute to this rise already exist. But their goal is to prove their prior assumption that vaccines are safe and harms are “rare.” The only reason they even pretend to care about vaccine safety is that they want to avoid reduction in vaccine uptake – not actually assure safety!

KANSAS ATTORNEY GENERAL'S SUIT AGAINST PFIZER USES KEY EVIDENCE OBTAINED BY ICAN

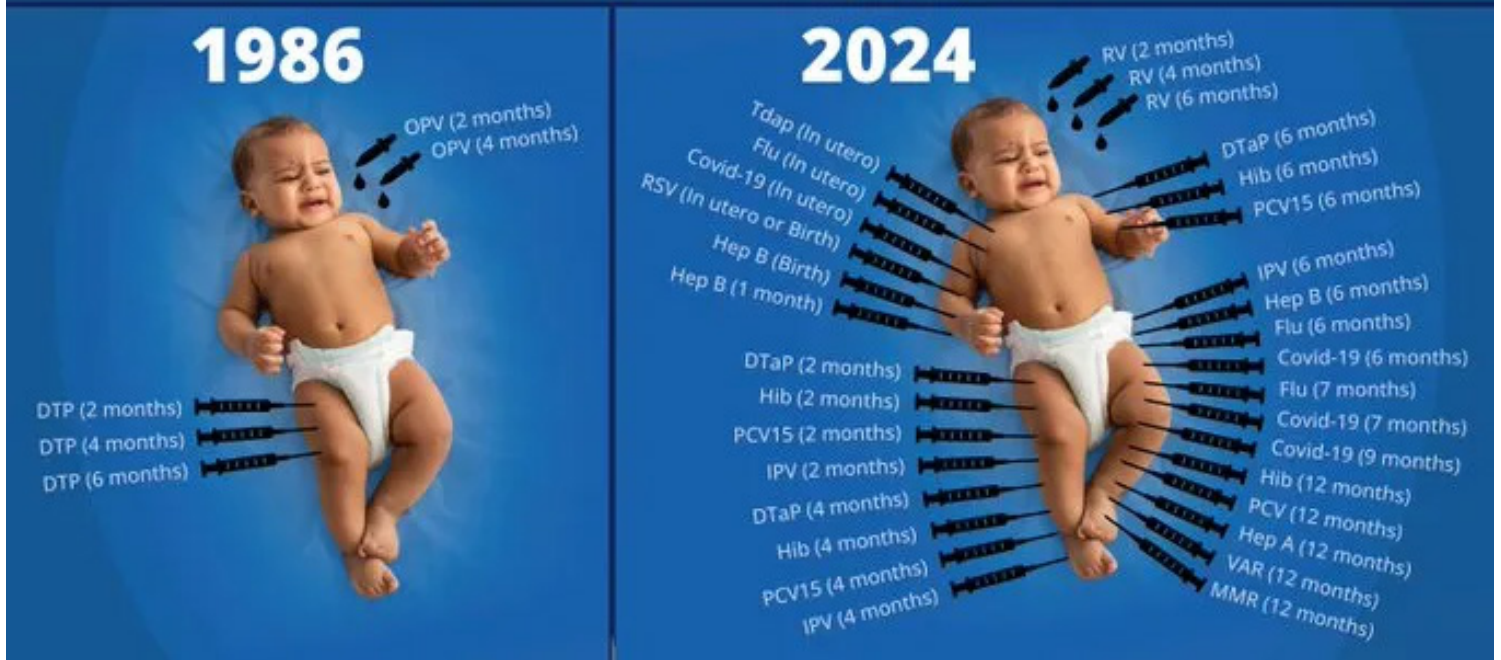

If you have not seen the image above before, please take a moment to really let this image we created sink in—and keep in mind that this only reflects the vaccines given during pregnancy and the first year of life (there are far more thereafter on the current schedule). Also keep in mind that virtually

every single one of today’s vaccines was developed by a pharma company knowing it would not face liability for injuries caused by these products. This is because, as most of you know, the [National Childhood Vaccine Injury Act of 1986](#) gave them immunity from having to pay for harms. And chronic

childhood diseases, many of which are autoimmune or immune-mediated, have exploded from 12.4% in the early 1980s to over 50 percent of children today. CDC and public “health” authorities cannot figure out the cause despite desperately searching (though they haven’t studied vaccines, even

though smaller independent studies have indicated vaccines are a major contributor). With that in mind, let the chart below also sink in, comparing the clinical trials relied upon to license Pfizer’s top five selling products (excluding the COVID-19 vaccine) with vaccines given in the first six months of life.

Founder of Moms Across America shares the alarming results of a recent study with Pediatrician Michelle Perro, MD, testing the leading infant formulas for toxic metals. 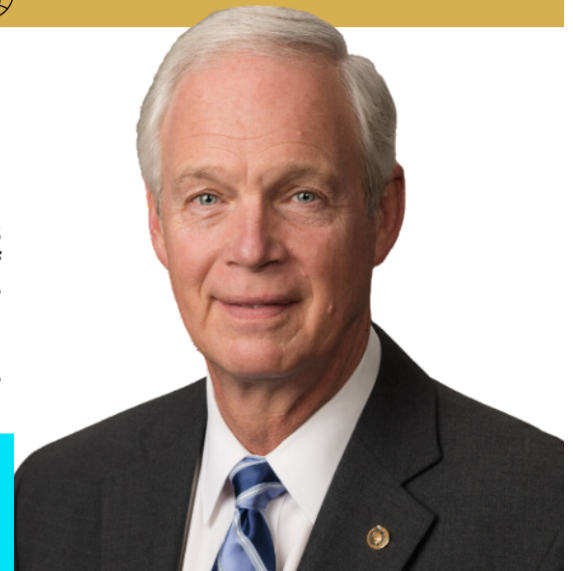


SENATOR RON JOHNSON | EP 382

Sen. We have important issues to address, but if we're just screaming at each other instead of listening to those with different perspectives, then shame on us."

With what was a lifetime of learning behind me, I was in a unique position—as more and more people started opening their eyes to the lies of corporate media, very few of them knew what was really happening.

Given my knowledge of history, when the *Wikileaks* emails came out, I was able to quickly make sense of them all. I began to detail every email in the series and explain the real connections between the people, places, and things. I was excited, for it was a much-needed service, and I was happy to provide it. After all, an informed populace makes informed decisions.

However, my quest to spread knowledge among all those who would listen started much earlier, in my early 20s. I had the distinct pleasure of meeting a woman who I am still proud to call one of my dearest friends and a colleague—[Gigi Bowman](#). Gigi and I both lived on Long Island in New York. Quite unfortunately, Gigi had lost her 15-year-old daughter to suicide. She was prescribed Zoloft for depression. The medication was contraindicated for her age group. As I, a mother, empathized with her deep sorrow and pain, I also joined in her fight to educate the public about the dangers of Big Pharma.

Thus, my passion was ignited, and my career was born. I often get frustrated with the state of things today. It's nearly impossible for the average person to tell which end is up. Between social media, corporate media, and censorship,

it is a wonder any of us are informed at all. But when I stepped away from that corporate career, I vowed to prioritize honesty and integrity. People needed somewhere to get it straight with no spin, even if it wasn't what they wanted to hear. For this purpose, I created my outlet, [UncoverDC](#), where my team of writers and I combine in-depth investigative journalism with sharp wit and pop culture insights to explore complex political issues. It's also where I host my podcast, [Dark To Light](#). Our goal is to shed light on government corruption and deliver important news while offering our audience a chance to engage with the content in an enjoyable and relatable way.

In 2019, I was asked to be the official media correspondent for a conference. It was there that Gigi Bowman grabbed my hand and ran me over to where Del Bigtree and *The HighWire* crew were sitting. I had known and followed them in the past, but it was imperative that I meet them in person. Gigi wouldn't have it any other

way, as she too, had been an avid consumer of all things *HighWire* and ICAN—for obvious reasons.

We got together and immediately clicked. I can explain why from my perspective. It was because, for the first time in my career, I had met a group of people as dedicated to integrity, the cause, and the truth as I was. There was no doubt in my mind about who they were as people. There was no doubt in my mind what their principles were. And time only proved those initial thoughts correct.

When COVID hit in 2020, *UncoverDC* was one of the few outlets providing honest and unbiased journalism about the pandemic and health freedom. In April 2020, we were blessed to publish the first column outlining the [dangers of using PCR](#) for testing. We were able to do it because journalist Celia Farber, who had covered the AIDS epidemic, had countless discussions with the inventor of PCR, Dr. Kary Mullis. She knew that PCR wasn't designed to test for anything because of her reporting from that time. We broke several stories during COVID, and like many, were banned for our honest reporting. But we had a friend in ICAN and *The HighWire*. I directed as many as possible to their information. I firmly believe that countless numbers of people were saved because of the honest, fearless journalism done by Del and the team. I also believe that if it hadn't been for ICAN's advocacy for bodily autonomy, properly informed consent, and legal action, many more would be without the knowledge of the harms of the "medicine" big pharma and governments around the world were forced on their people.

I am known for my in-depth analysis of the legal system. I am the journalist many come to when looking for a summary and timeline of an active court case. I have read thousands of cases. Counting on the legal team at ICAN has been one of the more fulfilling and heartwarming parts of my work. I know when an ICAN suit is filed, it is going

to move the ball. As you know, they absolutely do.

I have often been criticized for being so strict about the information I publish and the people I choose to lend a voice to with my platform. I have received countless emails scolding me about what I should and shouldn't cover and why. I decided early on to align myself with very few because even one mistake by someone you have forged an alliance with can threaten everything you have worked so very hard to build.

I never have to worry about that with this team. It has been my lifetime honor to call myself a [part of the family](#). When I began [writing editorially](#) for them with my dear and brilliant colleague Michelle Edwards, I was so proud of the work we were able to publish, and I continue to beam twice a week as we inform more and more. They had the same standards as we did at *UncoverDC*, making me feel so comfortable and proud to have a byline.

It was an honor to host the show, and who knows? I may be back again soon...

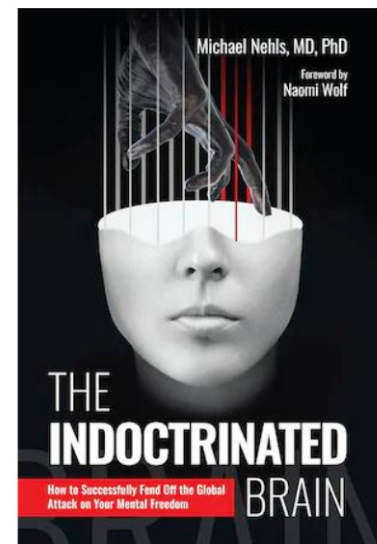
