Dr Woodcock and colleagues.

I have not yet received word from Dr Marks or others in regards to to my inquiry on the 16th.

I would appreciate a follow-up please. Each day that passes enduring like this is inhumane. I do believe I have made it clear that the suffering is immense. It also is especially cruel to leave those suffering these reactions out to fend for themselves. I have said it many times before, we cannot get care...period.

The FDA's own Pfizer EUA document states that 4.4% of Pfizer recipients suffered AEs categorized as "Nervous System Disorder" there is no further discussion as to what this means or why nearly 5 of every 100 doses produces such a reaction. Similar numbers are reported for Moderna and JnJ as well.

John's Hopkins defines Nervous system disorder as:

- Persistent or sudden onset of a headache
- A headache that changes or is different
- Loss of feeling or tingling
- Weakness or loss of muscle strength
- Loss of sight or double vision
- Memory loss
- Impaired mental ability
- Lack of coordination
- Muscle rigidity

- Back pain which radiates to the feet, toes, or other parts of the body
- Muscle wasting and slurred speech
- New language impairment (expression or comprehension)

These symptoms seem very similar to mine and those of the many thousands of Americans who have managed to find us.

It would seem obvious to the most casual observer that the events from the clinical trials would repeat in the public roll-out, including nervous system disorders.
