Dear Dr. Woodcock,

Thank you for being careful about releasing the vaccines to children. I wish you had been more careful for adults. I have been severely ill for nine months now with tremors, burning numbness in my face and limbs, twitching, dizziness, tinnitus, tight constriction around my chest, double vision, imbalance. This all started 30 minutes after receiving the Pfizer vaccine on 12/23/20. I fear for my life. I get attacks where I feel like I am being electrocuted. This can last for several hours. I just had one. I can't get medical help because doctors don't understand what is causing these reactions. They are dismissive and dumbfounded. They have never been told about these reactions. I have seen many including Dr. Nath's group at the NIH. I have spoken to you by email many times. Others in my group have pleaded to you for help.

I desperately need help as does my group of 160 with similar horrific neurological reactions to the vaccines. Many of us are physicians. There are many 1000's more. I know that you know this.

We had a zoom meeting with Peter Marks but he didn't show up. As we thought, nothing came of the meeting. I would be happy to send you a transcript of the meeting, presentations by 4 injured physicians, one PA and one teacher.

When are these reactions going to be acknowledged by the FDA and vaccine manufacturers? When will we be given help? I wish you could experience what we are going through. Maybe your actions to get us help would be very different.

Please stop ignoring me and the many others who have been suffering indescribable pain from the vaccines. We have no one to help us and no where to turn. I, for one, am desperate.
